10. WILLS AND TRUSTS
11. SECURED TRANSACTIONS

THE MEE QUESTIONS OFTEN INVOLVE A COMBINATION OF THESE SUBJECTS, REQUIRING EXAMINEES TO DEMONSTRATE THEIR ABILITY TO INTEGRATE KNOWLEDGE ACROSS DISCIPLINES.

## FACTORS INFLUENCING MEE PREDICTIONS

SEVERAL FACTORS PLAY A SIGNIFICANT ROLE IN PREDICTING THE SUBJECTS AND ISSUES THAT MAY APPEAR ON THE JULY 2023 MEE. THESE FACTORS INCLUDE HISTORICAL TRENDS, RECENT DEVELOPMENTS IN LEGAL EDUCATION, AND CURRENT LEGAL ISSUES BEING DEBATED IN COURTS.

## RECENT DEVELOPMENTS IN LEGAL EDUCATION

### MODERATELY LIKELY SUBJECTS

1. CRIMINAL LAW AND PROCEDURE: WITH ONGOING DISCUSSIONS AROUND CRIMINAL JUSTICE REFORM, EXPECT QUESTIONS THAT MAY INCORPORATE ELEMENTS OF BOTH SUBSTANTIVE CRIMINAL LAW AND PROCEDURAL ISSUES.
2. TORTS: ISSUES RELATED TO LIABILITY, NEGLIGENCE, AND DAMAGES CONTINUE TO BE RELEVANT, MAKING TORTS A PROBABLE SUBJECT.
3. FAMILY LAW: AS SOCIAL DYNAMICS EVOLVE, QUESTIONS RELATED TO CUSTODY, DIVORCE, AND PROPERTY DIVISION MAY APPEAR.

## LESS LIKELY BUT POSSIBLE SUBJECTS

1. BUSINESS ASSOCIATIONS: WHILE IMPORTANT, THIS AREA IS LESS FREQUENTLY TESTED. HOWEVER, WITH THE RISE OF CORPORATE ACCOUNTABILITY ISSUES, IT COULD MAKE AN APPEARANCE.
2. PROPERTY: TRADITIONAL PROPERTY LAW QUESTIONS MAY BE LESS COMMON, BUT SPECIFIC ISSUES REGARDING LAND USE AND RIGHTS COULD EMERGE.
3. WILLS AND TRUSTS: THIS SUBJECT IS OFTEN TESTED BUT MAY TAKE A BACKSEAT TO MORE PRESSING SOCIAL ISSUES.

## PREPARATION STRATEGIES FOR EXAMINEES

TO MAXIMIZE THEIR CHANCES OF SUCCESS, EXAMINEES SHOULD CONSIDER THE FOLLOWING PREPARATION STRATEGIES:

1. REVIEW PAST EXAMS: STUDYING PAST MEE QUESTIONS CAN HELP FAMILIARIZE CANDIDATES WITH THE FORMAT AND TYPES OF ISSUES THAT MAY ARISE.
2. PRACTICE WRITING ESSAYS: TIME MANAGEMENT IS VITAL. REGULARLY PRACTICING WRITING ESSAYS UNDER TIMED CONDITIONS CAN HELP IMPROVE THIS SKILL.
3. FOCUS ON HIGH-FREQUENCY SUBJECTS: PRIORITIZE STUDYING SUBJECTS THAT ARE HISTORICALLY MORE LIKELY TO BE TESTED.
4. STAY UPDATED ON CURRENT EVENTS: KEEPING ABREAST OF RECENT LEGAL DEVELOPMENTS CAN PROVIDE CONTEXT AND RELEVANCE TO POTENTIAL EXAM QUESTIONS.
5. JOIN STUDY GROUPS: COLLABORATING WITH PEERS CAN FOSTER UNDERSTANDING AND PROVIDE DIVERSE PERSPECTIVES ON COMPLEX LEGAL ISSUES.
