KOREMATSU V. UNITED STATES 1944 WORKSHEET ANSWER KEY IS A CRUCIAL TOPIC RELATED TO ONE OF THE MOST SIGNIFICANT SUPREME COURT CASES IN AMERICAN HISTORY. THE CASE, DECIDED DURING WORLD WAR II, INVOLVED THE FORCED RELOCATION AND INTERNMENT OF JAPANESE AMERICANS BY THE U.S. GOVERNMENT. UNDERSTANDING THE IMPLICATIONS OF THIS CASE IS ESSENTIAL FOR COMPREHENDING THE BALANCE BETWEEN NATIONAL SECURITY AND CIVIL LIBERTIES, AS WELL AS THE JUDICIAL SYSTEM'S ROLE IN SUCH MATTERS. HISTORICAL CONTEXT

DURING WORLD WAR II, FOLLOWING THE ATTACK ON PEARL HARBOR IN DECEMBER 1941, FEAR AND PARANOIA REGARDING JAPANESE AMERICANS SURGED. THE U.S. GOVERNMENT, INFLUENCED BY MILITARY AND POLITICAL LEADERS, VIEWED JAPANESE AMERICANS AS POTENTIAL THREATS TO NATIONAL SECURITY. THIS FEAR WAS EXACERBATED BY EXISTING RACIAL PREJUDICES AND STEREOTYPES.

EXECUTIVE ORDER 9066

ON FEBRUARY 19, 1942, PRESIDENT FRANKLIN D. ROOSEVELT SIGNED EXECUTIVE ORDER 9066, WHICH AUTHORIZED THE MILITARY TO DESIGNATE "MILITARY AREAS" AND EXCLUDE ANYONE DEEMED A THREAT. THIS ORDER LED TO THE INTERNMENT OF APPROXIMATELY 120,000 JAPANESE AMERICANS, TWO-THIRDS OF WHOM WERE U.S. CITIZENS. THE INTERNMENT CAMPS WERE ESTABLISHED IN ISOLATED AREAS, OFTEN IN HARSH CONDITIONS.

THE CASE: KOREMATSU V. UNITED STATES

FRED KOREMATSU, AN AMERICAN CITIZEN OF JAPANESE DESCENT, REFUSED TO COMPLY WITH THE INTERNMENT ORDER AND WAS SUBSEQUENTLY ARRESTED. KOREMATSU'S CASE BECAME A TEST OF THE CONSTITUTIONALITY OF THE INTERNMENT POLICY.

LEGAL ARGUMENTS

THE CORE LEGAL ARGUMENTS IN KOREMATSU V. UNITED STATES REVOLVED AROUND CIVIL LIBERTIES, THE EQUAL PROTECTION CLAUSE, AND THE QUESTION OF WHETHER THE GOVERNMENT HAD THE AUTHORITY TO INFRINGE UPON INDIVIDUAL RIGHTS IN THE NAME OF NATIONAL SECURITY.

1. PETITIONER'S ARGUMENTS (KOREMATSU):

- KOREMATSU ARGUED THAT THE INTERNMENT WAS BASED ON RACIAL PREJUDICE RATHER THAN ANY LEGITIMATE MILITARY JUSTIFICATION.
- HE ASSERTED THAT THE INTERNMENT VIOLATED THE FIFTH AMENDMENT, WHICH GUARANTEES DUE PROCESS.
- KOREMATSU EMPHASIZED THE LACK OF EVIDENCE SHOWING THAT JAPANESE AMERICANS POSED A THREAT TO NATIONAL SECURITY.

2. RESPONDENT'S ARGUMENTS (UNITED STATES):

- THE GOVERNMENT ARGUED THAT THE INTERNMENT WAS A NECESSARY WARTIME MEASURE TO PREVENT ESPIONAGE AND SABOTAGE.
- THEY CLAIMED THAT THE MILITARY HAD MADE ITS DECISION BASED ON THE WARTIME CONTEXT AND THE PERCEIVED THREAT POSED BY JAPANESE AMERICANS.
- THE GOVERNMENT MAINTAINED THAT THE INTERNMENT WAS A VALID EXERCISE OF EXECUTIVE POWER IN TIMES OF NATIONAL EMERGENCY.

THE SUPREME COURT DECISION

ON DECEMBER 18, 1944, THE SUPREME COURT DELIVERED A 6-3 RULING IN FAVOR OF THE UNITED STATES, UPHOLDING THE CONSTITUTIONALITY OF THE INTERNMENT ORDER. JUSTICE HUGO BLACK WROTE THE MAJORITY OPINION, EMPHASIZING THE GOVERNMENT'S DUTY TO PROTECT THE NATION DURING WARTIME.

KEY POINTS FROM THE RULING

- THE COURT ACCEPTED THE GOVERNMENT'S ARGUMENTS ABOUT THE NECESSITY OF INTERNMENT FOR NATIONAL SECURITY.
- THE DECISION WAS HEAVILY INFLUENCED BY THE PREVAILING WARTIME CONTEXT AND THE DEFERENCE GIVEN TO MILITARY JUDGMENT IN CRITICAL SITUATIONS.
- THE RULING DID NOT FIND THE INTERNMENT TO BE A VIOLATION OF THE EQUAL PROTECTION CLAUSE, DESPITE THE OBVIOUS RACIAL BASIS FOR THE POLICY.

CRITICISM AND DISSSENT

THE DECISION FACED IMMEDIATE CRITICISM, AND DISSENTING OPINIONS HIGHLIGHTED THE DANGERS OF RACIAL PREJUDICE INFLUENCING LEGAL JUDGMENTS.

1. DISSENTING OPINIONS:

- JUSTICE MURPHY NOTED THAT THE INTERNMENT ORDER WAS BASED ON RACIAL PREJUDICE AND VIOLATED THE PRINCIPLES OF A DEMOCRATIC SOCIETY.
- JUSTICE JACKSON ARGUED THAT THE RULING SET A DANGEROUS PRECEDENT BY ALLOWING THE GOVERNMENT TO INFRINGE UPON INDIVIDUAL RIGHTS WITHOUT SUFFICIENT JUSTIFICATION.
- HE WARNED THAT THE RULING COULD HAVE LONG-LASTING IMPLICATIONS FOR CIVIL LIBERTIES IN AMERICA.

IMPACT AND LEGACY

THE KOREMATSU V. UNITED STATES RULING HAS HAD A PROFOUND AND LASTING IMPACT ON AMERICAN LAW AND SOCIETY.

POST-WAR REPERCUSSIONS

- AFTER THE WAR, THE INTERNMENT CAMPS WERE CLOSED, AND MANY JAPANESE AMERICANS RETURNED TO FIND THEIR HOMES AND BUSINESSES DESTROYED.
- IN 1988, THE U.S. GOVERNMENT FORMALLY ACKNOWLEDGED THE INJUSTICES OF INTERNMENT BY ENACTING THE CIVIL LIBERTIES ACT, WHICH PROVIDED REPARATIONS TO SURVIVORS.

MODERN IMPLICATIONS

- KOREMATSU'S CASE IS FREQUENTLY CITED IN DISCUSSIONS ABOUT CIVIL LIBERTIES, ESPECIALLY IN THE CONTEXT OF NATIONAL SECURITY.
- THE CASE SERVES AS A CAUTIONARY TALE AGAINST ALLOWING FEAR TO OVERRIDE CONSTITUTIONAL RIGHTS.
- LEGAL SCHOLARS AND ACTIVISTS OFTEN REFERENCE KOREMATSU IN CONTEMPORARY DEBATES REGARDING IMMIGRATION, SURVEILLANCE, AND THE TREATMENT OF MINORITY GROUPS DURING PERIODS OF NATIONAL CRISIS.

1. WHAT WAS EXECUTIVE ORDER 9066?

- EXECUTIVE ORDER 9066 WAS A DIRECTIVE SIGNED BY PRESIDENT ROOSEVELT THAT AUTHORIZED THE INTERNMENT OF JAPANESE AMERICANS DURING WORLD WAR II.

2. WHAT WERE THE MAIN ARGUMENTS PRESENTED BY KOREMATSU?

- KOREMATSU ARGUED THE INTERNMENT WAS RACIALLY MOTIVATED, VIOLATED DUE PROCESS UNDER THE FIFTH AMENDMENT, AND LACKED EVIDENCE OF A REAL THREAT.

3. WHAT WAS THE SUPREME COURT'S RULING IN KOREMATSU V. UNITED STATES?

- THE SUPREME COURT UPHELD THE INTERNMENT ORDER, RULING IT CONSTITUTIONAL BASED ON THE GOVERNMENT'S WARTIME POWERS.

4. WHAT WERE SOME CONSEQUENCES OF THE RULING?

- THE RULING LEGITIMIZED RACIAL DISCRIMINATION IN THE NAME OF NATIONAL SECURITY AND SET A PRECEDENT FOR FUTURE CASES INVOLVING CIVIL LIBERTIES.

5. HOW DID THE KOREMATSU CASE INFLUENCE FUTURE LEGAL DECISIONS?

- KOREMATSU IS OFTEN REFERENCED IN LEGAL DISCUSSIONS ABOUT CIVIL LIBERTIES AND GOVERNMENT OVERREACH, PARTICULARLY DURING TIMES OF CRISIS.

CONCLUSION

KOREMATSU V. UNITED STATES REMAINS A SIGNIFICANT CASE IN THE ANNALS OF AMERICAN LEGAL HISTORY. IT HIGHLIGHTS THE TENSIONS BETWEEN NATIONAL SECURITY AND CIVIL LIBERTIES AND SERVES AS A REMINDER OF THE DANGERS POSED BY UNCHECKED GOVERNMENTAL POWER. UNDERSTANDING THE COMPLEXITIES OF THIS CASE THROUGH WORKSHEETS AND DISCUSSIONS HELPS ENSURE THAT THE MISTAKES OF THE PAST ARE NOT REPEATED IN THE FUTURE.

FREQUENTLY ASKED QUESTIONS

WHAT WAS THE MAIN ISSUE AT STAKE IN KOREMATSU V. UNITED STATES?

THE MAIN ISSUE WAS WHETHER THE GOVERNMENT'S DECISION TO INTERN JAPANESE AMERICANS DURING WORLD WAR II WAS A VIOLATION OF THEIR CONSTITUTIONAL RIGHTS.

WHAT WAS THE SUPREME COURT'S RULING IN KOREMATSU V. UNITED STATES?

THE SUPREME COURT RULED IN A 6-3 DECISION THAT THE INTERNMENT WAS CONSTITUTIONAL, CITING NATIONAL SECURITY CONCERNS DURING WARTIME.

HOW HAS KOREMATSU V. UNITED STATES BEEN VIEWED IN SUBSEQUENT YEARS?

THE CASE HAS BEEN CITED IN LATER SUPREME COURT DECISIONS REGARDING CIVIL RIGHTS AND NATIONAL SECURITY, OFTEN AS A CAUTIONARY EXAMPLE OF THE DANGERS OF PRIORITIZING SECURITY OVER LIBERTY.

WHAT WAS FRED KOREMATSU'S ARGUMENT AGAINST THE INTERNMENT?

FRED KOREMATSU ARGUED THAT THE INTERNMENT WAS RACIALLY DISCRIMINATORY AND VIOLATED HIS RIGHTS UNDER THE FIFTH AMENDMENT.

WHAT HAS BEEN THE LEGACY OF KOREMATSU V. UNITED STATES IN AMERICAN HISTORY?

THE CASE IS OFTEN CITED IN DISCUSSIONS ABOUT THE BALANCE BETWEEN NATIONAL SECURITY AND CIVIL LIBERTIES, SERVING AS A REMINDER OF THE POTENTIAL FOR GOVERNMENTAL OVERREACH IN TIMES OF CRISIS.
