- DATABASE MANAGEMENT SYSTEM (E.G., MICROSOFT SQL SERVER, ORACLE).
- WEB SERVER SOFTWARE (IF APPLICABLE).

INSTALLATION STEPS

1. DOWNLOAD THE INSTALLATION PACKAGE:
 - OBTAIN THE LABWARE LIMS v7 INSTALLATION PACKAGE FROM THE OFFICIAL LABWARE WEBSITE OR AUTHORIZED DISTRIBUTOR.

- TEST INTEGRATION:
 - VALIDATE THE INTEGRATION BY PERFORMING TEST RUNS TO ENSURE ACCURATE DATA CAPTURE AND REPORTING.

OPERATING LABWARE LIMS v7

ONCE CONFIGURED, OPERATING LABWARE LIMS v7 INVOLVES REGULAR TASKS THAT USERS MUST PERFORM TO MAINTAIN SYSTEM EFFICIENCY AND DATA INTEGRITY.

ROUTINE OPERATIONS
