GOALS, OBJECTIVES, AND OUTCOMES

BUDGET DEVELOPMENT

DEVELOPING A DETAILED AND REALISTIC BUDGET IS A CRITICAL SKILL COVERED IN TRAINING SESSIONS. PARTICIPANTS LEARN TO ITEMIZE COSTS, JUSTIFY EXPENSES, AND ENSURE COMPLIANCE WITH FUNDING GUIDELINES. PROPER BUDGET PRESENTATION REFLECTS CAREFUL PLANNING AND ENHANCES PROPOSAL CREDIBILITY.
