UNDERSTANDING THE LAW OF EXPONENTS

$$A^M \times A^N = A^{M+N}$$

QUOTIENT OF POWERS RULE

WHEN DIVIDING EXPRESSIONS WITH THE SAME BASE, THE EXPONENTS ARE SUBTRACTED. THIS RULE IS VITAL FOR SIMPLIFYING FRACTIONAL EXPRESSIONS INVOLVING POWERS:

$$A^M \div A^N = A^{M-N}, \text{ WHERE } A \neq 0$$

POWER OF A POWER RULE

RAISING A POWER TO ANOTHER POWER INVOLVES MULTIPLYING THE EXPONENTS. THIS LAW SIMPLIFIES EXPRESSIONS WHERE AN EXPONENT IS APPLIED TO AN ALREADY EXPONENTIATED BASE:

$$(A^M)^N = A^{M \times N}$$

POWER OF A PRODUCT RULE

THIS LAW STATES THAT THE POWER OF A PRODUCT IS EQUAL TO THE PRODUCT OF EACH FACTOR RAISED TO THE POWER:

$$(AB)^N = A^N \times B^N$$

ZERO AND NEGATIVE EXPONENTS

THE ZERO EXPONENT RULE INDICATES THAT ANY NONZERO BASE RAISED TO THE ZERO POWER EQUALS ONE:

$$A^0 = 1, \text{ WHERE } A \neq 0$$

NEGATIVE EXPONENTS REPRESENT THE RECIPROCAL OF THE BASE RAISED TO THE CORRESPONDING POSITIVE EXPONENT:

$$A^{-N} = 1 \div A^N, \text{ WHERE } A \neq 0$$

COMPONENTS OF AN EFFECTIVE LAW OF EXPONENTS WORKSHEET
