DEFINITION AND SCOPE OF LAW OF THE LAND

TERRITORIAL JURISDICTION

MARITIME ZONES

THE LAW OF THE SEA DEFINES SEVERAL MARITIME ZONES, EACH WITH SPECIFIC LEGAL REGIMES:

- **TERRITORIAL SEA:** EXTENDS UP TO 12 NAUTICAL MILES FROM THE BASELINE, WHERE THE COASTAL STATE EXERCISES SOVEREIGNTY SIMILAR TO ITS LAND TERRITORY.

- **HIGH SEAS:** AREAS BEYOND NATIONAL JURISDICTION, WHERE FREEDOM OF NAVIGATION AND OTHER FREEDOMS APPLY.

SCOPE OF REGULATION

THE LAW OF THE SEA REGULATES A BROAD RANGE OF ACTIVITIES, INCLUDING MARINE ENVIRONMENTAL PROTECTION, SHIPPING, FISHING, SEABED MINING, AND THE SETTLEMENT OF MARITIME DISPUTES. IT BALANCES THE INTERESTS OF COASTAL STATES WITH THOSE OF THE INTERNATIONAL COMMUNITY.

HISTORICAL DEVELOPMENT

JURISDICTION AND ENFORCEMENT

JURISDICTION UNDER THE LAW OF THE LAND AND LAW OF THE SEA DIFFERS SIGNIFICANTLY IN SCOPE AND ENFORCEMENT MECHANISMS.
