POWER RULE

ZERO EXPONENT RULE

ANY NON-ZERO BASE RAISED TO THE ZERO POWER EQUALS ONE: $A^0 = 1$. THIS RULE IS FUNDAMENTAL IN SIMPLIFYING EXPRESSIONS AND UNDERSTANDING THE PROPERTIES OF EXPONENTS.

NEGATIVE EXPONENT RULE

SOLUTION: MULTIPLY EXPONENTS: $3 \times 4 = 12$. FINAL EXPRESSION: 2^{12} .

EXAMPLE 4: ZERO EXPONENT RULE

SIMPLIFY: 7^0

SOLUTION: ANY NON-ZERO NUMBER RAISED TO ZERO IS 1.

EXAMPLE 5: NEGATIVE EXPONENT RULE

SIMPLIFY: 4^{-2}

SOLUTION: CONVERT TO RECIPROCAL: $1 \div 4^2 = 1/16$.
