SALARY AND EMPLOYMENT PROSPECTS DIFFER FOR GRADUATES OF LEGAL STUDIES VERSUS PARALEGAL PROGRAMS DUE TO THE VARYING NATURE OF THE ROLES AND QUALIFICATIONS REQUIRED.

LEGAL STUDIES SALARY AND MARKET

CHOOSING BETWEEN LEGAL STUDIES AND PARALEGAL
