## 5. USE THE PROCESS OF ELIMINATION

IN MULTIPLE-CHOICE SECTIONS, IF YOU'RE UNSURE OF AN ANSWER, USE THE PROCESS OF ELIMINATION TO NARROW DOWN YOUR OPTIONS. THIS TECHNIQUE CAN INCREASE YOUR CHANCES OF SELECTING THE CORRECT ANSWER.
