- **AGREED-UPON ACTIONS:** DOCUMENTING THE DECISIONS MADE AND THE STEPS EACH PARTY COMMITS TO TAKING.

THESE ELEMENTS ENSURE THAT THE MAJOR CLASH COMPROMISE WORKSHEET CAPTURES A FULL PICTURE OF THE CONFLICT AND FOSTERS CONSTRUCTIVE DIALOGUE TOWARD RESOLUTION.

8. **FOLLOW-UP:** SCHEDULE REVIEW SESSIONS TO ENSURE COMPLIANCE AND ADDRESS ANY EMERGING ISSUES.
