MANDATED REPORTERS OFTEN HAVE THE OPTION TO REMAIN ANONYMOUS BUT ARE ENCOURAGED TO PROVIDE THEIR IDENTITY TO AID INVESTIGATIONS.

RECOGNIZING SIGNS OF ABUSE AND NEGLECT
