5. **EQUIPMENT:** APPLIANCES, LIGHTING, AND OTHER ELECTRICAL DEVICES GENERATE HEAT, CONTRIBUTING TO THE OVERALL LOAD.
6. **AIR INFILTRATION:** THE AMOUNT OF OUTDOOR AIR THAT ENTERS THE BUILDING AFFECTS HEATING AND COOLING REQUIREMENTS.

THE RESULT OF A MANUAL J CALCULATION IS TYPICALLY EXPRESSED IN BTUs (BRITISH THERMAL UNITS) PER HOUR, WHICH SERVES AS A BENCHMARK FOR SELECTING HVAC EQUIPMENT.

UNDERSTANDING MANUAL S

WHILE MANUAL J FOCUSES ON LOAD CALCULATIONS, MANUAL S IS CONCERNED WITH THE SELECTION OF HVAC EQUIPMENT BASED ON THOSE CALCULATIONS. MANUAL S PROVIDES GUIDELINES FOR CHOOSING THE APPROPRIATE SIZE AND TYPE OF HEATING AND COOLING SYSTEMS TO ENSURE THEY OPERATE EFFICIENTLY AND EFFECTIVELY.

5. **VERIFY MANUFACTURER SPECIFICATIONS:** EQUIPMENT MUST MEET SPECIFIC MANUFACTURER PERFORMANCE CRITERIA, ENSURING IT CAN HANDLE THE CALCULATED LOADS EFFECTIVELY.

CHOOSING THE RIGHT HVAC EQUIPMENT IS ESSENTIAL FOR ACHIEVING THE DESIRED COMFORT LEVELS WHILE MINIMIZING ENERGY CONSUMPTION.

THE IMPORTANCE OF MANUAL J AND MANUAL S IN HVAC DESIGN
