WHAT IS THE MINIMUM AGE TO OBTAIN A CDL IN MARYLAND?

THE MINIMUM AGE TO OBTAIN A COMMERCIAL DRIVER'S LICENSE (CDL) IN MARYLAND IS 18 YEARS OLD FOR INTRASTATE DRIVING AND 21 YEARS OLD FOR INTERSTATE DRIVING.

WHAT ARE THE DIFFERENT CLASSES OF CDL IN MARYLAND?

IN MARYLAND, THERE ARE THREE CLASSES OF CDL: CLASS A FOR COMBINATION VEHICLES, CLASS B FOR SINGLE VEHICLES OVER 26,000 POUNDS, AND CLASS C FOR SMALLER VEHICLES DESIGNED TO TRANSPORT 16 OR MORE PASSENGERS OR HAZARDOUS MATERIALS.

WHAT TESTS ARE REQUIRED TO OBTAIN A CDL IN MARYLAND?

TO OBTAIN A CDL IN MARYLAND, YOU MUST PASS A VISION TEST, A KNOWLEDGE TEST, AND A SKILLS TEST, WHICH INCLUDES A PRE-TRIP INSPECTION, BASIC VEHICLE CONTROL, AND ON-ROAD DRIVING.

HOW CAN I PREPARE FOR THE MARYLAND CDL KNOWLEDGE TEST?

TO PREPARE FOR THE MARYLAND CDL KNOWLEDGE TEST, STUDY THE MARYLAND COMMERCIAL DRIVER'S HANDBOOK, TAKE PRACTICE TESTS AVAILABLE ONLINE, AND FAMILIARIZE YOURSELF WITH THE TYPES OF QUESTIONS THAT MAY BE ASKED.

WHAT DOCUMENTS DO I NEED TO BRING FOR THE CDL TEST IN MARYLAND?

YOU NEED TO BRING A VALID MARYLAND DRIVER'S LICENSE, PROOF OF RESIDENCY, A COMPLETED APPLICATION FORM, AND ANY REQUIRED FEES TO THE CDL TEST IN MARYLAND.

CAN I TAKE THE MARYLAND CDL TEST IN A LANGUAGE OTHER THAN ENGLISH?

YES, MARYLAND OFFERS THE CDL KNOWLEDGE TEST IN MULTIPLE LANGUAGES. YOU CAN REQUEST THE TEST IN A SPECIFIC LANGUAGE WHEN YOU APPLY.

WHAT SHOULD I DO IF I BELIEVE MY CDL TEST RESULTS WERE INCORRECT?

IF YOU BELIEVE YOUR CDL TEST RESULTS WERE INCORRECT, YOU SHOULD CONTACT THE MARYLAND MOTOR VEHICLE ADMINISTRATION (MVA) TO DISCUSS YOUR CONCERNS AND INQUIRE ABOUT THE PROCESS FOR DISPUTING THE RESULTS.
