

# MARYLAND NURSING PRACTICE ACT

THE MARYLAND NURSING PRACTICE ACT IS A CRITICAL PIECE OF LEGISLATION THAT GOVERNS THE PRACTICE OF NURSING WITHIN THE STATE OF MARYLAND.
