

MICHIGAN PHYSICAL THERAPY LICENSE REQUIREMENTS

MICHIGAN PHYSICAL THERAPY LICENSE REQUIREMENTS ARE ESSENTIAL FOR ANYONE LOOKING TO PRACTICE PHYSICAL THERAPY IN THE STATE. THE LICENSING PROCESS ENSURES THAT PHYSICAL THERAPISTS MEET THE NECESSARY EDUCATIONAL AND PROFESSIONAL STANDARDS TO PROVIDE SAFE AND EFFECTIVE CARE TO PATIENTS. EDUCATIONAL REQUIREMENTS

TO QUALIFY FOR A PHYSICAL THERAPY LICENSE IN MICHIGAN, CANDIDATES MUST COMPLETE A SPECIFIC EDUCATIONAL PATHWAY. HERE ARE THE KEY STEPS INVOLVED:

1. EARN A DEGREE FROM AN ACCREDITED PROGRAM

- CANDIDATES MUST EARN A DOCTOR OF PHYSICAL THERAPY (DPT) DEGREE FROM A PROGRAM ACCREDITED BY THE COMMISSION ON ACCREDITATION IN PHYSICAL THERAPY EDUCATION (CAPTE).
- THE DPT PROGRAM TYPICALLY INCLUDES BOTH COURSEWORK AND CLINICAL INTERNSHIPS, ENSURING THAT GRADUATES HAVE A COMPREHENSIVE UNDERSTANDING OF PHYSICAL THERAPY PRACTICES.

2. COMPLETE CLINICAL EXPERIENCE

- AS PART OF THE DPT PROGRAM, STUDENTS ARE REQUIRED TO COMPLETE A CERTAIN NUMBER OF CLINICAL HOURS UNDER THE SUPERVISION OF LICENSED PHYSICAL THERAPISTS.
- CLINICAL EXPERIENCES PROVIDE HANDS-ON TRAINING AND ARE CRUCIAL FOR DEVELOPING PRACTICAL SKILLS NECESSARY FOR PATIENT CARE.

EXAMINATION REQUIREMENTS

AFTER COMPLETING THE EDUCATIONAL REQUIREMENTS, THE NEXT STEP FOR CANDIDATES IS TO PASS THE NECESSARY EXAMINATIONS.

1. NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE)

- CANDIDATES MUST PASS THE NPTE, WHICH IS ADMINISTERED BY THE FEDERATION OF STATE BOARDS OF PHYSICAL THERAPY (FSBPT).
- THIS EXAMINATION ASSESSES THE CANDIDATE'S KNOWLEDGE AND COMPETENCIES IN PHYSICAL THERAPY PRACTICES.

- A PASSING SCORE IS REQUIRED TO MOVE FORWARD IN THE LICENSING PROCESS.

2. MICHIGAN JURISPRUDENCE EXAMINATION

- IN ADDITION TO THE NPTE, CANDIDATES MUST ALSO PASS THE MICHIGAN JURISPRUDENCE EXAMINATION.
- THIS EXAM FOCUSES ON STATE LAWS AND REGULATIONS RELATED TO THE PRACTICE OF PHYSICAL THERAPY IN MICHIGAN.
- THE JURISPRUDENCE EXAM ENSURES THAT CANDIDATES UNDERSTAND THE LEGAL RESPONSIBILITIES AND ETHICAL CONSIDERATIONS INVOLVED IN THEIR PRACTICE.

APPLICATION PROCESS FOR LICENSURE

ONCE CANDIDATES HAVE COMPLETED THEIR EDUCATION AND PASSED THE NECESSARY EXAMINATIONS, THEY CAN BEGIN THE APPLICATION PROCESS FOR LICENSURE IN MICHIGAN.

1. GATHER REQUIRED DOCUMENTATION

CANDIDATES NEED TO COMPILE SEVERAL DOCUMENTS AS PART OF THEIR APPLICATION, INCLUDING:

- OFFICIAL TRANSCRIPTS FROM THE DPT PROGRAM
- PROOF OF PASSING SCORES ON THE NPTE AND MICHIGAN JURISPRUDENCE EXAMINATION
- COMPLETED APPLICATION FORM
- APPLICATION FEE PAYMENT

2. SUBMIT APPLICATION TO LARA

- APPLICATIONS MUST BE SUBMITTED TO THE MICHIGAN DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS (LARA) THROUGH THEIR ONLINE PORTAL OR BY MAIL.
- IT IS ESSENTIAL TO ENSURE THAT ALL REQUIRED DOCUMENTATION IS COMPLETE TO AVOID DELAYS IN PROCESSING.

3. BACKGROUND CHECK

- CANDIDATES ARE REQUIRED TO UNDERGO A CRIMINAL BACKGROUND CHECK AS PART OF THE APPLICATION PROCESS.
- THIS STEP ENSURES THAT ALL PHYSICAL THERAPISTS PRACTICING IN MICHIGAN HAVE A CLEAR RECORD, WHICH IS VITAL FOR PATIENT SAFETY.

CONTINUING EDUCATION REQUIREMENTS

AFTER OBTAINING LICENSURE, PHYSICAL THERAPISTS IN MICHIGAN MUST MAINTAIN THEIR LICENSE THROUGH CONTINUING EDUCATION.

1. CONTINUING EDUCATION CREDITS

- LICENSED PHYSICAL THERAPISTS ARE REQUIRED TO COMPLETE 30 HOURS OF CONTINUING EDUCATION EVERY TWO YEARS.
- THESE CREDITS CAN BE EARNED THROUGH VARIOUS ACTIVITIES, INCLUDING WORKSHOPS, SEMINARS, AND ONLINE COURSES

RELATED TO PHYSICAL THERAPY.

2. RENEWAL PROCESS

- LICENSES MUST BE RENEWED EVERY TWO YEARS. THE RENEWAL APPLICATION SHOULD BE SUBMITTED TO LARA ALONG WITH PROOF OF COMPLETED CONTINUING EDUCATION CREDITS AND THE APPLICABLE RENEWAL FEE.
- IT IS ESSENTIAL FOR PHYSICAL THERAPISTS TO STAY UPDATED ON THE LATEST PRACTICES AND DEVELOPMENTS IN THE FIELD TO PROVIDE THE BEST CARE FOR THEIR PATIENTS.

TRANSFERRING LICENSES TO MICHIGAN

PHYSICAL THERAPISTS WHO ARE LICENSED IN OTHER STATES AND WISH TO PRACTICE IN MICHIGAN MUST ALSO MEET CERTAIN REQUIREMENTS.

1. VERIFICATION OF LICENSURE

- CANDIDATES MUST PROVIDE VERIFICATION OF THEIR CURRENT LICENSE FROM THE STATE WHERE THEY ARE CURRENTLY PRACTICING.
- THIS PROCESS USUALLY INVOLVES SUBMITTING A FORM TO THE LICENSING AUTHORITY IN THE ORIGINAL STATE FOR VERIFICATION.

2. PASS THE NPTE AND JURISPRUDENCE EXAM

- EVEN IF A CANDIDATE IS ALREADY LICENSED IN ANOTHER STATE, THEY ARE STILL REQUIRED TO PASS THE NPTE AND THE MICHIGAN JURISPRUDENCE EXAMINATION.
- THIS ENSURES THAT ALL PRACTICING PHYSICAL THERAPISTS IN MICHIGAN ARE FAMILIAR WITH STATE-SPECIFIC LAWS AND REGULATIONS.

3. APPLICATION FOR LICENSURE BY ENDORSEMENT

- CANDIDATES CAN APPLY FOR LICENSURE BY ENDORSEMENT, WHICH IS THE PROCESS FOR TRANSFERRING AN OUT-OF-STATE LICENSE TO MICHIGAN.
- THEY MUST SUBMIT AN APPLICATION, PROVIDE REQUIRED DOCUMENTATION, AND PAY THE APPROPRIATE FEES.

WHAT ARE THE BASIC EDUCATIONAL REQUIREMENTS TO OBTAIN A PHYSICAL THERAPY LICENSE IN MICHIGAN?

TO OBTAIN A PHYSICAL THERAPY LICENSE IN MICHIGAN, YOU MUST HAVE A DOCTOR OF PHYSICAL THERAPY (DPT) DEGREE FROM A CAPTE-ACCREDITED PROGRAM.

IS THERE A CLINICAL EXPERIENCE REQUIREMENT FOR PHYSICAL THERAPY LICENSURE IN MICHIGAN?

YES, APPLICANTS MUST COMPLETE AT LEAST 30 WEEKS OF CLINICAL EXPERIENCE AS PART OF THEIR DPT PROGRAM, INCLUDING SUPERVISED CLINICAL INTERNSHIPS.

WHAT EXAMINATION MUST BE PASSED TO BECOME A LICENSED PHYSICAL THERAPIST IN MICHIGAN?

CANDIDATES MUST PASS THE NATIONAL PHYSICAL THERAPY EXAMINATION (NPTE) ADMINISTERED BY THE FEDERATION OF STATE BOARDS OF PHYSICAL THERAPY (FSBPT).

ARE THERE ANY CONTINUING EDUCATION REQUIREMENTS FOR MAINTAINING A PHYSICAL THERAPY LICENSE IN MICHIGAN?

YES, LICENSED PHYSICAL THERAPISTS IN MICHIGAN MUST COMPLETE AT LEAST 30 HOURS OF CONTINUING EDUCATION EVERY TWO YEARS TO RENEW THEIR LICENSE.

WHAT IS THE APPLICATION PROCESS FOR OBTAINING A PHYSICAL THERAPY LICENSE IN MICHIGAN?

THE APPLICATION PROCESS INCLUDES SUBMITTING AN APPLICATION FORM, PROOF OF EDUCATION, PROOF OF PASSING THE NPTE, AND PAYING THE REQUIRED FEES TO THE MICHIGAN DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS (LARA).

CAN PHYSICAL THERAPISTS FROM OTHER STATES APPLY FOR LICENSURE IN MICHIGAN?

YES, PHYSICAL THERAPISTS LICENSED IN OTHER STATES CAN APPLY FOR LICENSURE IN MICHIGAN, BUT THEY MUST MEET MICHIGAN'S REQUIREMENTS AND PROVIDE VERIFICATION OF THEIR CREDENTIALS.
