CLINICIANS UTILIZE THE MRS TO DETERMINE TREATMENT EFFICACY, TRACK RECOVERY PROGRESS, AND FACILITATE COMMUNICATION AMONG HEALTHCARE PROVIDERS. THE SCALE'S SIMPLICITY AND REPRODUCIBILITY MAKE IT A STANDARD IN BOTH CLINICAL PRACTICE AND RESEARCH TRIALS.

4. **3:** MODERATE DISABILITY; REQUIRING SOME HELP BUT ABLE TO WALK WITHOUT ASSISTANCE.
5. **4:** MODERATELY SEVERE DISABILITY; UNABLE TO WALK WITHOUT ASSISTANCE AND UNABLE TO ATTEND TO OWN BODILY NEEDS WITHOUT ASSISTANCE.
6. **5:** SEVERE DISABILITY; BEDRIDDEN, INCONTINENT, AND REQUIRING CONSTANT NURSING CARE AND ATTENTION.
7. **6:** DEAD.

EACH SCORE REFLECTS INCREASING LEVELS OF DISABILITY OR DEPENDENCE. PROPER SCORING REQUIRES A THOROUGH PATIENT INTERVIEW AND OBSERVATION, FOCUSING ON THE ABILITY TO PERFORM DAILY ACTIVITIES AND LEVEL OF ASSISTANCE NEEDED.

COMMON MODIFIED RANKIN SCALE CERTIFICATION TEST ANSWERS
