 - CLASSROOM MANAGEMENT AND INSTRUCTIONAL STRATEGIES

PREPARING FOR THE EXAM

- HISTORICAL ERAS: REVIEW THE CHARACTERISTICS AND SIGNIFICANT COMPOSERS OF THE BAROQUE, CLASSICAL, ROMANTIC, AND 20TH CENTURY PERIODS.
- CULTURAL CONTEXT: UNDERSTAND HOW SOCIETAL CHANGES INFLUENCED MUSIC COMPOSITION AND PERFORMANCE PRACTICES THROUGHOUT HISTORY.
- MAJOR WORKS: FAMILIARIZE YOURSELF WITH SEMINAL WORKS AND THEIR COMPOSERS, SUCH AS BACH'S "BRANDENBURG CONCERTOS" OR BEETHOVEN'S "SYMPHONIES."

MUSIC PEDAGOGY AND ASSESSMENT

- TEACHING METHODS: EXPLORE VARIOUS TEACHING PHILOSOPHIES, INCLUDING ORFF, KODÁLY, AND DALCROZE, AND THEIR APPLICATIONS IN THE CLASSROOM.
- CURRICULUM PLANNING: UNDERSTAND HOW TO DESIGN A MUSIC CURRICULUM THAT MEETS EDUCATIONAL STANDARDS AND CATERES TO DIVERSE LEARNERS.
- ASSESSMENT STRATEGIES: LEARN HOW TO ASSESS STUDENT PROGRESS THROUGH FORMATIVE AND SUMMATIVE ASSESSMENTS IN MUSIC.

TEST-TAKING STRATEGIES

IN ADDITION TO CONTENT KNOWLEDGE, EFFECTIVE TEST-TAKING STRATEGIES CAN IMPROVE YOUR PERFORMANCE ON THE PRAXIS MUSIC 5113 EXAM.

TIME MANAGEMENT

- ELIMINATE WRONG ANSWERS: USE THE PROCESS OF ELIMINATION TO NARROW DOWN YOUR ANSWER CHOICES AND INCREASE YOUR CHANCES OF SELECTING THE CORRECT ANSWER.

STAY CALM AND CONFIDENT

- PRACTICE RELAXATION TECHNIQUES: ENGAGE IN DEEP-BREATHING EXERCISES OR VISUALIZATION TECHNIQUES BEFORE AND DURING THE EXAM TO MANAGE ANXIETY.
- POSITIVE MINDSET: MAINTAIN A POSITIVE ATTITUDE, REMINDING YOURSELF OF THE PREPARATION YOU HAVE COMPLETED.
