NAVY SEA SERVICE DEPLOYMENT RIBBON INSTRUCTION SERVES AS A CRUCIAL GUIDE FOR UNDERSTANDING THE ELIGIBILITY, AWARDING CRITERIA, AND PROPER WEAR OF THE NAVY SEA SERVICE DEPLOYMENT RIBBON. THIS ARTICLE COMPREHENSIVELY COVERS THE ESSENTIAL ASPECTS OF THIS MILITARY DECORATION, INCLUDING ITS HISTORY, QUALIFICATION REQUIREMENTS, AND HOW SERVICE MEMBERS SHOULD DISPLAY IT ON THEIR UNIFORMS. THE NAVY SEA SERVICE DEPLOYMENT RIBBON IS AWARDED TO MEMBERS OF THE U.S. NAVY WHO COMPLETE A QUALIFYING SEA DUTY DEPLOYMENT, RECOGNIZING THEIR DEDICATION AND SERVICE AT SEA. UNDERSTANDING THE SPECIFIC INSTRUCTIONS FOR THIS RIBBON IS VITAL FOR BOTH SERVICE MEMBERS AND ADMINISTRATIVE PERSONNEL TO ENSURE ACCURATE RECOGNITION AND COMPLIANCE WITH NAVY REGULATIONS. OVERVIEW OF THE NAVY SEA SERVICE DEPLOYMENT RIBBON

THE NAVY SEA SERVICE DEPLOYMENT RIBBON IS A MILITARY AWARD ESTABLISHED TO RECOGNIZE U.S. NAVY PERSONNEL WHO HAVE COMPLETED SPECIFIC SEA DUTY DEPLOYMENTS. INSTITUTED IN 1980, THIS RIBBON HIGHLIGHTS THE IMPORTANCE OF SEA SERVICE IN MAINTAINING NAVAL READINESS AND OPERATIONAL CAPABILITY. IT SERVES NOT ONLY AS A SYMBOL OF INDIVIDUAL ACHIEVEMENT BUT ALSO AS A TESTAMENT TO THE COLLECTIVE EFFORT OF NAVY PERSONNEL DEPLOYED ABOARD SHIPS, SUBMARINES, OR DESIGNATED SEA DUTY ASSIGNMENTS. THE RIBBON'S DESIGN INCORPORATES COLORS AND PATTERNS THAT REFLECT THE MARITIME ENVIRONMENT AND NAVY HERITAGE.

ELIGIBILITY CRITERIA AND QUALIFICATION REQUIREMENTS

TO BE ELIGIBLE FOR THE NAVY SEA SERVICE DEPLOYMENT RIBBON, SERVICE MEMBERS MUST MEET DEFINED DEPLOYMENT AND DUTY REQUIREMENTS. THESE CRITERIA ENSURE THAT THE RIBBON IS AWARDED ONLY TO THOSE WHO HAVE COMPLETED MEANINGFUL SEA SERVICE IN SUPPORT OF NAVAL OPERATIONS. UNDERSTANDING THESE ELIGIBILITY STANDARDS IS ESSENTIAL TO CORRECTLY ADMINISTER THE AWARD AND MAINTAIN UNIFORMITY ACROSS COMMANDS.

BASIC ELIGIBILITY REQUIREMENTS

THE PRIMARY CRITERIA FOR RECEIVING THE NAVY SEA SERVICE DEPLOYMENT RIBBON INCLUDE:

- COMPLETION OF A MINIMUM OF 90 CONSECUTIVE DAYS OF DEPLOYMENT ABOARD A NAVY VESSEL OR WITH AN ELIGIBLE SEA DUTY COMMAND.
- DEPLOYMENT MUST BE IN SUPPORT OF OPERATIONAL MISSIONS, INCLUDING OVERSEAS OR FORWARD-DEPLOYED ASSIGNMENTS.

- SERVICE MEMBERS MUST BE ASSIGNED TO COMMANDS THAT QUALIFY AS SEA DUTY FOR THE PURPOSE OF THIS AWARD.
- RESERVE COMPONENT MEMBERS MAY QUALIFY IF THEY MEET THE ACTIVE DUTY SEA SERVICE REQUIREMENTS DURING MOBILIZATION OR ACTIVE DUTY PERIODS.

TYPES OF DEPLOYMENTS THAT QUALIFY

ELIGIBLE DEPLOYMENTS GENERALLY INCLUDE:

- SERVING ABOARD SHIPS OR SUBMARINES DEPLOYED AWAY FROM THE HOMEPORT FOR OPERATIONAL MISSIONS.
- ASSIGNMENTS WITH UNITS THAT DEPLOY WITH A NAVAL EXPEDITIONARY FORCE OR PARTICIPATE IN EXTENDED SEA DUTY.
- CERTAIN OVERSEAS ASSIGNMENTS DESIGNATED BY THE NAVY AS SEA DUTY.

NOT ALL SEA DUTY COUNTS TOWARD THE RIBBON; SHORE-BASED ASSIGNMENTS, TRAINING CRUISES, OR SHORT TRANSITS TYPICALLY DO NOT QUALIFY.

INSTRUCTIONS FOR AWARDING THE RIBBON

THE PROCESS FOR AWARDING THE NAVY SEA SERVICE DEPLOYMENT RIBBON INVOLVES VERIFYING QUALIFYING SERVICE AND ENSURING PROPER DOCUMENTATION IS PROVIDED. COMMANDING OFFICERS AND ADMINISTRATIVE PERSONNEL ARE RESPONSIBLE FOR CONFIRMING ELIGIBILITY AND SUBMITTING AWARD RECOMMENDATIONS IN ACCORDANCE WITH NAVY PERSONNEL POLICIES.

VERIFICATION AND DOCUMENTATION

TO AWARD THE RIBBON, COMMANDS MUST:

- REVIEW DEPLOYMENT RECORDS AND PERSONNEL SERVICE HISTORY TO CONFIRM THE MINIMUM SEA DUTY DURATION.
- ENSURE THE DEPLOYMENT MEETS OPERATIONAL CRITERIA ESTABLISHED BY THE NAVAL MILITARY PERSONNEL COMMAND.
- DOCUMENT THE QUALIFYING PERIOD OF SERVICE IN OFFICIAL PERSONNEL RECORDS.

AWARD APPROVAL PROCESS

ONCE ELIGIBILITY IS CONFIRMED, THE FOLLOWING STEPS OCCUR:

1. COMMANDING OFFICER ENDORSES THE AWARD RECOMMENDATION.
2. PERSONNEL OFFICE PROCESSES THE AWARD THROUGH OFFICIAL CHANNELS.
3. THE AWARD IS ENTERED INTO THE SERVICE MEMBER'S OFFICIAL MILITARY RECORD.
4. THE SERVICE MEMBER IS NOTIFIED AND AUTHORIZED TO WEAR THE RIBBON.

PROPER WEAR AND DISPLAY OF THE RIBBON

CORRECT PLACEMENT AND DISPLAY OF THE NAVY SEA SERVICE DEPLOYMENT RIBBON ARE GOVERNED BY THE NAVY UNIFORM REGULATIONS. ADHERING TO THESE INSTRUCTIONS ENSURES UNIFORMITY AND RESPECT FOR THE SIGNIFICANCE OF THE AWARD.

PLACEMENT ON THE UNIFORM

THE RIBBON IS WORN ON THE LEFT SIDE OF THE UNIFORM, IN THE ORDER OF PRECEDENCE ESTABLISHED BY THE DEPARTMENT OF THE NAVY. IT IS TYPICALLY DISPLAYED ALONGSIDE OTHER SERVICE AND CAMPAIGN RIBBONS.

GUIDELINES FOR DIFFERENT UNIFORMS

SPECIFIC UNIFORM TYPES DICTATE HOW AND WHERE THE RIBBON IS WORN:

- **SERVICE DRESS UNIFORM:** THE RIBBON IS WORN CENTERED ON THE LEFT CHEST ABOVE THE POCKET.
- **WORKING UNIFORMS:** RIBBONS MAY BE WORN ON DESIGNATED RIBBON RACKS OR PATCHES AS AUTHORIZED.
- **MEDALS AND DECORATIONS:** FOR FORMAL OCCASIONS, THE RIBBON'S CORRESPONDING MEDAL (IF APPLICABLE) MAY BE WORN INSTEAD.

MULTIPLE AWARDS AND DEVICES

SERVICE MEMBERS WHO COMPLETE MULTIPLE QUALIFYING SEA DEPLOYMENTS MAY BE AUTHORIZED TO WEAR ADDITIONAL DEVICES ON THE NAVY SEA SERVICE DEPLOYMENT RIBBON. THESE DEVICES DENOTE THE NUMBER OF TIMES THE RIBBON HAS BEEN AWARDED AND PROVIDE A VISUAL RECORD OF SUSTAINED SEA SERVICE.

RECOGNITION OF ADDITIONAL AWARDS

SUBSEQUENT AWARDS OF THE RIBBON ARE REPRESENTED BY BRONZE SERVICE STARS ATTACHED TO THE RIBBON. A SILVER SERVICE STAR TYPICALLY INDICATES FIVE BRONZE STARS, SIGNIFYING MULTIPLE DEPLOYMENTS.

DEVICE PLACEMENT AND REGULATIONS

THE DEVICES MUST BE PLACED ON THE RIBBON IN ACCORDANCE WITH NAVY UNIFORM STANDARDS, ENSURING CLARITY AND UNIFORMITY. PROPER SPACING AND ALIGNMENT ARE ESSENTIAL TO MAINTAIN THE RIBBON'S APPEARANCE AND SIGNIFICANCE.

REQUESTING AND VERIFYING THE RIBBON

SERVICE MEMBERS SEEKING TO CONFIRM OR REQUEST THE NAVY SEA SERVICE DEPLOYMENT RIBBON MUST FOLLOW ESTABLISHED PROCEDURES TO ENSURE THEIR RECORDS ACCURATELY REFLECT THEIR ELIGIBILITY. THIS PROCESS OFTEN INVOLVES COORDINATION WITH PERSONNEL OFFICES AND REVIEW OF OFFICIAL DEPLOYMENT DOCUMENTATION.

HOW TO REQUEST THE RIBBON

- SUBMIT A FORMAL REQUEST THROUGH THE CHAIN OF COMMAND OR PERSONNEL ADMINISTRATION OFFICE.
- PROVIDE SUPPORTING DOCUMENTATION, SUCH AS DEPLOYMENT ORDERS AND SERVICE RECORDS.
- AWAIT VERIFICATION AND APPROVAL FROM THE APPROPRIATE AUTHORITY.

VERIFYING ELIGIBILITY

PERSONNEL OFFICES CAN ASSIST IN VERIFYING ELIGIBILITY BY CROSS-REFERENCING DEPLOYMENT DATES, SEA DUTY ASSIGNMENTS, AND OPERATIONAL RECORDS. MAINTAINING ACCURATE AND UP-TO-DATE RECORDS IS CRITICAL FOR TIMELY AWARDING OF THE NAVY SEA SERVICE DEPLOYMENT RIBBON.

FREQUENTLY ASKED QUESTIONS

WHAT IS THE NAVY SEA SERVICE DEPLOYMENT RIBBON?

THE NAVY SEA SERVICE DEPLOYMENT RIBBON IS A MILITARY AWARD PRESENTED TO MEMBERS OF THE U.S. NAVY WHO COMPLETE QUALIFYING SEA DEPLOYMENTS. IT RECOGNIZES SERVICE ON A VESSEL OR WITH A SEA DUTY UNIT FOR A SPECIFIED PERIOD.

WHAT ARE THE ELIGIBILITY REQUIREMENTS FOR THE NAVY SEA SERVICE DEPLOYMENT RIBBON?

TO BE ELIGIBLE, A SERVICE MEMBER MUST COMPLETE 90 CONSECUTIVE DAYS OR TWO PERIODS OF AT LEAST 80 DAYS EACH DEPLOYED ABOARD A NAVY OR MARINE CORPS SHIP OR WITH A DEPLOYABLE UNIT ASSIGNED TO A NAVY ACTIVITY.

HOW IS THE NAVY SEA SERVICE DEPLOYMENT RIBBON WORN ON THE UNIFORM?

THE NAVY SEA SERVICE DEPLOYMENT RIBBON IS WORN ON THE LEFT CHEST, IN THE ORDER OF PRECEDENCE PRESCRIBED BY THE NAVY'S UNIFORM REGULATIONS, TYPICALLY AFTER THE NAVY AND MARINE CORPS OVERSEAS SERVICE RIBBON.

CAN THE NAVY SEA SERVICE DEPLOYMENT RIBBON BE AWARDED MULTIPLE TIMES?

YES, ADDITIONAL AWARDS OF THE NAVY SEA SERVICE DEPLOYMENT RIBBON ARE DENOTED BY BRONZE SERVICE STARS ON THE RIBBON, INDICATING MULTIPLE QUALIFYING DEPLOYMENTS.

WHERE CAN I FIND THE OFFICIAL INSTRUCTION FOR THE NAVY SEA SERVICE DEPLOYMENT RIBBON?

THE OFFICIAL INSTRUCTION AND DETAILED CRITERIA FOR THE NAVY SEA SERVICE DEPLOYMENT RIBBON ARE OUTLINED IN THE NAVY UNIFORM REGULATIONS AND THE DEPARTMENT OF THE NAVY AWARDS MANUAL, TYPICALLY AVAILABLE THROUGH THE NAVY PERSONNEL COMMAND WEBSITE.

DOES THE NAVY SEA SERVICE DEPLOYMENT RIBBON APPLY TO RESERVE PERSONNEL?

YES, NAVY RESERVE PERSONNEL WHO MEET THE SEA DUTY AND DEPLOYMENT CRITERIA DURING ACTIVE DUTY OR MOBILIZATION PERIODS ARE ELIGIBLE TO RECEIVE THE NAVY SEA SERVICE DEPLOYMENT RIBBON.
