THE EXAM FOCUSES ON HANDS-ON SKILLS, INCLUDING HAIR CUTTING, STYLING, CHEMICAL TREATMENTS, AND SANITATION PRACTICES. PASSING THE PRACTICAL EXAM IS MANDATORY TO OBTAIN A COSMETOLOGY LICENSE IN NORTH CAROLINA, ENSURING PUBLIC SAFETY AND PROFESSIONAL COMPETENCE. THIS EXAM COMPLEMENTS THE WRITTEN PORTION, WHICH TESTS THEORETICAL KNOWLEDGE OF COSMETOLOGY PRINCIPLES AND STATE LAWS.

ELIGIBILITY AND APPLICATION PROCESS

FEES AND SCHEDULING
