OVERVIEW OF THE NC PROPERTY AND CASUALTY EXAM

ELIGIBILITY AND REGISTRATION

TO BE ELIGIBLE FOR THE EXAM, APPLICANTS MUST MEET CERTAIN STATE REQUIREMENTS, INCLUDING AGE AND RESIDENCY CRITERIA. RISK AND RISK MANAGEMENT

RISK REFERS TO THE UNCERTAINTY REGARDING FINANCIAL LOSS. PROPERTY AND CASUALTY INSURANCE PRIMARILY DEALS WITH MANAGING RISKS RELATED TO PROPERTY DAMAGE AND LIABILITY. RISK MANAGEMENT INVOLVES IDENTIFYING, ASSESSING, AND PRIORITIZING RISKS FOLLOWED BY APPLYING RESOURCES TO MINIMIZE OR CONTROL THEIR IMPACT. UNDERSTANDING THESE CONCEPTS IS VITAL FOR EVALUATING INSURANCE NEEDS AND COVERAGE OPTIONS.

INSURANCE CONTRACTS AND PRINCIPLES

INSURANCE CONTRACTS ARE LEGALLY BINDING AGREEMENTS BETWEEN THE INSURER AND THE INSURED. KEY PRINCIPLES INCLUDE UTMOST GOOD FAITH, INDEMNITY, INSURABLE INTEREST, AND SUBROGATION. THESE DOCTRINES ENSURE FAIRNESS AND CLARITY IN THE INSURANCE RELATIONSHIP. FOR EXAMPLE, INDEMNITY PREVENTS THE INSURED FROM PROFITING FROM A LOSS, WHILE INSURABLE INTEREST REQUIRES THE INSURED TO HAVE A FINANCIAL STAKE IN THE INSURED PROPERTY OR PERSON.

TYPES OF PROPERTY AND CASUALTY INSURANCE POLICIES

HOMEOWNERS INSURANCE

HOMEOWNERS INSURANCE PROVIDES COVERAGE FOR DAMAGE TO A DWELLING AND PERSONAL PROPERTY CAUSED BY EVENTS SUCH AS FIRE, THEFT, OR NATURAL DISASTERS. IT ALSO OFFERS LIABILITY PROTECTION AGAINST INJURIES OR DAMAGES OCCURRING ON THE INSURED PROPERTY. DIFFERENT FORMS OF HOMEOWNERS POLICIES EXIST, SUCH AS HO-3 AND HO-5, WITH VARYING LEVELS OF COVERAGE.

AUTOMOBILE INSURANCE

AUTO INSURANCE POLICIES COVER LIABILITY, COLLISION, AND COMPREHENSIVE LOSSES RELATED TO VEHICLES. LIABILITY INSURANCE PROTECTS THE INSURED WHEN THEY CAUSE BODILY INJURY OR PROPERTY DAMAGE TO OTHERS, WHILE COLLISION AND COMPREHENSIVE COVER PHYSICAL DAMAGE TO THE INSURED VEHICLE. KNOWLEDGE OF MANDATORY STATE MINIMUMS AND OPTIONAL COVERAGES IS ESSENTIAL FOR THE EXAM.

COMMERCIAL PROPERTY AND LIABILITY INSURANCE

COMMERCIAL PROPERTY INSURANCE COVERS BUILDINGS, EQUIPMENT, AND INVENTORY OWNED BY BUSINESSES. LIABILITY INSURANCE PROTECTS BUSINESSES FROM CLAIMS ARISING FROM BODILY INJURY, PROPERTY DAMAGE, OR NEGLIGENCE. UNDERSTANDING BUSINESS OWNERS POLICIES (BOPs) AND SPECIALIZED COVERAGES FOR DIFFERENT INDUSTRIES IS IMPORTANT FOR LICENSING CANDIDATES.

NORTH CAROLINA INSURANCE LAWS AND REGULATIONS

STATE-SPECIFIC LAWS AND REGULATIONS GOVERN THE PRACTICE OF INSURANCE IN NORTH CAROLINA.
