- **ENGAGE IN COMMUNITY WORK:** PARTICIPATE IN OR SUPPORT INITIATIVES AIMED AT ADDRESSING RACIAL INEQUALITIES. THIS COULD INVOLVE VOLUNTEERING, ORGANIZING EVENTS, OR SUPPORTING LOCAL BUSINESSES.
- **ADVOCATE FOR POLICY CHANGES:** USE YOUR VOICE TO ADVOCATE FOR POLICIES THAT PROMOTE EQUITY AND JUSTICE IN YOUR COMMUNITY. THIS INCLUDES VOTING, ATTENDING TOWN HALL MEETINGS, AND CONTACTING YOUR REPRESENTATIVES.
- **FOSTER OPEN DIALOGUE:** CREATE SPACES FOR OPEN DISCUSSIONS ABOUT RACE AND RACISM. ENCOURAGE FRIENDS, FAMILY, AND COLLEAGUES TO SHARE THEIR EXPERIENCES AND PERSPECTIVES.

THE IMPACT OF NEELY FULLER JR.'S CODE
