EXAM FEES AND REGISTRATION

TO SIT FOR THE EXAM, CANDIDATES MUST PAY A REGISTRATION FEE, WHICH CAN VARY. AS OF THE LATEST INFORMATION, THE FEE IS APPROXIMATELY \$45. YOU WILL NEED TO REGISTER THROUGH THE NEW JERSEY DIVISION OF CONSUMER AFFAIRS AND MAY NEED TO PROVIDE PROOF OF COMPLETION OF A PRE-LICENSING COURSE.

- WEEK 4: PRACTICE QUESTIONS (STATE)
- WEEK 5: REVIEW WEAK AREAS AND TAKE FULL-LENGTH PRACTICE EXAMS

UTILIZE STUDY GROUPS

- ENVIRONMENTAL REGULATIONS

TEST-TAKING TIPS

ON THE DAY OF THE EXAM, BEING PREPARED MENTALLY AND PHYSICALLY CAN MAKE A SIGNIFICANT DIFFERENCE. HERE ARE SOME TEST-TAKING STRATEGIES:

ARRIVE EARLY

GIVE YOURSELF ENOUGH TIME TO ARRIVE AT THE TESTING CENTER EARLY. THIS WILL ALLOW YOU TO SETTLE IN AND REDUCE ANXIETY.

READ QUESTIONS CAREFULLY

TAKE YOUR TIME TO READ EACH QUESTION AND ALL ANSWER CHOICES THOROUGHLY. PAY ATTENTION TO KEYWORDS SUCH AS “NOT” OR “EXCEPT” THAT CAN CHANGE THE MEANING OF A QUESTION.

ELIMINATE WRONG ANSWERS

IF YOU’RE UNSURE OF THE ANSWER, TRY TO ELIMINATE THE CHOICES THAT YOU KNOW ARE INCORRECT. THIS CAN INCREASE YOUR CHANCES OF SELECTING THE RIGHT ANSWER.

UNDERSTANDING NEW JERSEY REAL ESTATE LAWS

NEW JERSEY HAS SPECIFIC LAWS AND REGULATIONS THAT GOVERN REAL ESTATE PRACTICES. FAMILIARIZE YOURSELF WITH THE FOLLOWING TOPICS:

REAL ESTATE LICENSE TYPES

- SALESPERSON LICENSE: REQUIRED FOR INDIVIDUALS WORKING UNDER A BROKER.
- BROKER LICENSE: REQUIRED FOR INDIVIDUALS WHO WISH TO OPERATE THEIR OWN REAL ESTATE BUSINESS.

DISCLOSURE REQUIREMENTS

NEW JERSEY LAW MANDATES THAT SELLERS DISCLOSE KNOWN DEFECTS IN THE PROPERTY. FAMILIARIZE YOURSELF WITH THE REGULATIONS SURROUNDING THE SELLER’S DISCLOSURE STATEMENT.

FAIR HOUSING LAWS

UNDERSTAND THE FEDERAL AND STATE FAIR HOUSING LAWS THAT PROHIBIT DISCRIMINATION BASED ON RACE, COLOR, RELIGION, SEX, NATIONAL ORIGIN, FAMILIAL STATUS, AND DISABILITY.

POST-EXAM STEPS

ONCE YOU'VE SUCCESSFULLY PASSED THE NJ REAL ESTATE EXAM, THERE ARE A FEW MORE STEPS TO TAKE BEFORE YOU CAN START WORKING:

APPLYING FOR YOUR LICENSE

AFTER PASSING THE EXAM, YOU MUST APPLY FOR YOUR REAL ESTATE LICENSE THROUGH THE NEW JERSEY DIVISION OF CONSUMER AFFAIRS. ENSURE YOU HAVE ALL REQUIRED DOCUMENTATION AND FEES READY FOR SUBMISSION.

CONTINUING EDUCATION REQUIREMENTS

TO MAINTAIN YOUR REAL ESTATE LICENSE IN NEW JERSEY, YOU MUST COMPLETE CONTINUING EDUCATION COURSES EVERY TWO YEARS. STAY INFORMED ABOUT THE LATEST REGULATIONS AND TRENDS IN THE INDUSTRY THROUGH THESE COURSES.
