EDUCATIONAL REQUIREMENTS FOR MASSAGE THERAPY LICENSURE

ONE OF THE FOUNDATIONAL *NORTH CAROLINA MASSAGE THERAPY LICENSE REQUIREMENTS* IS THE COMPLETION OF AN APPROVED EDUCATIONAL PROGRAM. APPLICANTS MUST GRADUATE FROM A MASSAGE THERAPY SCHOOL THAT MEETS THE STATE'S STANDARDS, WHICH TYPICALLY INVOLVES COMPREHENSIVE TRAINING IN ANATOMY, PHYSIOLOGY, KINESIOLOGY, PATHOLOGY, AND HANDS-ON MASSAGE TECHNIQUES. THE NORTH CAROLINA BOARD OF MASSAGE AND BODYWORK THERAPY MANDATES THAT THE PROGRAM INCLUDE A MINIMUM NUMBER OF HOURS TO ENSURE ADEQUATE PREPARATION.

APPROVED MASSAGE THERAPY PROGRAMS

TO QUALIFY FOR LICENSURE, CANDIDATES MUST COMPLETE AN ACCREDITED PROGRAM RECOGNIZED BY THE NORTH CAROLINA LICENSING AUTHORITY. THESE PROGRAMS USUALLY CONSIST OF AT LEAST 500 HOURS OF INSTRUCTION, COMBINING CLASSROOM LEARNING AND SUPERVISED CLINICAL PRACTICE. COURSEWORK COVERS VARIOUS MASSAGE MODALITIES, ETHICS, CLIENT COMMUNICATION, AND SAFETY PROTOCOLS. VERIFYING PROGRAM APPROVAL BEFORE ENROLLMENT IS CRITICAL TO AVOID ISSUES DURING THE APPLICATION PROCESS.

MINIMUM TRAINING HOURS AND CURRICULUM

THE STATE REQUIRES A MINIMUM OF 500 HOURS OF FORMAL EDUCATION, DISTRIBUTED ACROSS THEORETICAL AND PRACTICAL COMPONENTS. CORE CURRICULUM AREAS INCLUDE:

EXAMINATION AND TESTING PROCEDURES

PASSING A RECOGNIZED EXAMINATION IS ANOTHER CRUCIAL **NORTH CAROLINA MASSAGE THERAPY LICENSE REQUIREMENTS**. THE BOARD REQUIRES APPLICANTS TO SUCCESSFULLY COMPLETE BOTH A WRITTEN AND PRACTICAL EXAM TO DEMONSTRATE COMPETENCY IN MASSAGE THERAPY PRINCIPLES AND TECHNIQUES.

NATIONAL CERTIFICATION EXAM

THE PRIMARY EXAMINATION ACCEPTED BY THE STATE IS THE MASSAGE & BODYWORK LICENSING EXAMINATION (MBLEX), ADMINISTERED BY THE FEDERATION OF STATE MASSAGE THERAPY BOARDS. THIS EXAM ASSESSES KNOWLEDGE IN AREAS SUCH AS ANATOMY, PHYSIOLOGY, CONTRAINDICATIONS, AND ETHICS. ACHIEVING A PASSING SCORE IS MANDATORY BEFORE PROCEEDING WITH LICENSURE.

PRACTICAL SKILLS ASSESSMENT

IN ADDITION TO THE WRITTEN EXAM, APPLICANTS MUST DEMONSTRATE THEIR HANDS-ON PROFICIENCY THROUGH A PRACTICAL SKILLS TEST. THIS EVALUATION ENSURES THAT THERAPISTS CAN APPLY TECHNIQUES SAFELY AND EFFECTIVELY IN A CLINICAL SETTING. THE PRACTICAL EXAM TYPICALLY COVERS VARIOUS MASSAGE MODALITIES AND CLIENT INTERACTION PROTOCOLS.

APPLICATION PROCESS FOR NORTH CAROLINA MASSAGE THERAPY LICENSE

REQUIRED DOCUMENTATION

APPLICANTS MUST PROVIDE THE FOLLOWING MATERIALS:

- OFFICIAL TRANSCRIPTS FROM AN APPROVED MASSAGE THERAPY PROGRAM
- PROOF OF PASSING THE MBLEX OR EQUIVALENT EXAM
- COMPLETED APPLICATION FORM WITH PERSONAL AND PROFESSIONAL INFORMATION
- PAYMENT OF APPLICABLE FEES
- BACKGROUND CHECK OR FINGERPRINTING AS REQUIRED

APPLICATION SUBMISSION AND FEES

THE APPLICATION MUST BE SUBMITTED EITHER ONLINE OR VIA MAIL, DEPENDING ON THE BOARD'S CURRENT PROCEDURES. FEES VARY AND TYPICALLY INCLUDE AN APPLICATION FEE AND A LICENSING FEE ONCE APPROVED. APPLICANTS ARE ADVISED TO REVIEW THE MOST RECENT FEE SCHEDULE TO ENSURE TIMELY PAYMENT AND AVOID DELAYS.

LICENSE RENEWAL AND CONTINUING EDUCATION

MAINTAINING A VALID LICENSE REQUIRES ADHERENCE TO RENEWAL GUIDELINES AND CONTINUING EDUCATION MANDATES. THESE ONGOING REQUIREMENTS PROMOTE PROFESSIONAL DEVELOPMENT AND COMPLIANCE WITH EVOLVING STANDARDS IN MASSAGE THERAPY PRACTICE.

RENEWAL PERIOD AND PROCESS

NORTH CAROLINA MASSAGE THERAPY LICENSES ARE GENERALLY VALID FOR A TWO-YEAR PERIOD. LICENSEES MUST SUBMIT A RENEWAL APPLICATION BEFORE THE EXPIRATION DATE, INCLUDING PAYMENT OF RENEWAL FEES. FAILURE TO RENEW ON TIME MAY RESULT IN PENALTIES OR LICENSE SUSPENSION.

CONTINUING EDUCATION REQUIREMENTS

TO QUALIFY FOR RENEWAL, LICENSED THERAPISTS MUST COMPLETE A SPECIFIED NUMBER OF CONTINUING EDUCATION HOURS. TYPICALLY, THIS INCLUDES COURSES RELATED TO ADVANCED MASSAGE TECHNIQUES, ETHICS, AND STATE LAWS. CONTINUING EDUCATION ENSURES THAT PRACTITIONERS STAY INFORMED ABOUT BEST PRACTICES AND NEW DEVELOPMENTS IN THE FIELD.

SCOPE OF PRACTICE AND LEGAL REGULATIONS

PROFESSIONAL CONDUCT AND ETHICS

THERAPISTS MUST ADHERE TO A CODE OF ETHICS ESTABLISHED BY THE BOARD, WHICH INCLUDES MAINTAINING CLIENT CONFIDENTIALITY, OBTAINING INFORMED CONSENT, AND PRACTICING WITHIN THEIR COMPETENCE LEVEL. VIOLATIONS CAN RESULT IN DISCIPLINARY ACTION OR REVOCATION OF THE LICENSE.

RECIPROCITY AND LICENSE TRANSFER OPTIONS

FOR MASSAGE THERAPISTS LICENSED IN OTHER STATES, NORTH CAROLINA OFFERS PATHWAYS TO OBTAIN LICENSURE THROUGH

RECIPROCITY AGREEMENTS OR ENDORSEMENT PROCESSES. THESE OPTIONS FACILITATE MOBILITY FOR PROFESSIONALS RELOCATING TO THE STATE.

ELIGIBILITY FOR RECIPROCITY

APPLICANTS SEEKING RECIPROCITY MUST HOLD A CURRENT, ACTIVE LICENSE IN ANOTHER STATE WITH EQUIVALENT OR HIGHER REQUIREMENTS. THEY MUST SUBMIT PROOF OF LICENSURE, EDUCATION, AND EXAMINATION SCORES TO THE NORTH CAROLINA BOARD FOR REVIEW.

APPLICATION FOR ENDORSEMENT

THE ENDORSEMENT PROCESS INVOLVES SUBMITTING AN APPLICATION SIMILAR TO NEW APPLICANTS BUT MAY WAIVE CERTAIN REQUIREMENTS IF THE OUT-OF-STATE CREDENTIALS MEET NORTH CAROLINA'S STANDARDS. BACKGROUND CHECKS AND FEES REMAIN MANDATORY COMPONENTS OF THE PROCESS.

FREQUENTLY ASKED QUESTIONS

WHAT ARE THE BASIC ELIGIBILITY REQUIREMENTS FOR A MASSAGE THERAPY LICENSE IN NORTH CAROLINA?

TO BE ELIGIBLE FOR A MASSAGE THERAPY LICENSE IN NORTH CAROLINA, APPLICANTS MUST BE AT LEAST 18 YEARS OLD, HAVE COMPLETED A MINIMUM OF 500 HOURS OF APPROVED MASSAGE THERAPY EDUCATION, AND PASS THE REQUIRED LICENSING EXAMS.

APPLICANTS MUST PASS THE MESSAGE & BODYWORK LICENSING EXAMINATION (MBLEX) ADMINISTERED BY THE FEDERATION OF STATE MESSAGE THERAPY BOARDS (FSMTB) TO QUALIFY FOR LICENSURE IN NORTH CAROLINA.

HOW MANY HOURS OF MASSAGE THERAPY EDUCATION ARE REQUIRED FOR LICENSURE IN NORTH CAROLINA?

NORTH CAROLINA REQUIRES A MINIMUM OF 500 HOURS OF EDUCATION IN MASSAGE THERAPY FROM AN APPROVED SCHOOL OR PROGRAM.

IS CPR CERTIFICATION REQUIRED FOR A MASSAGE THERAPY LICENSE IN NORTH CAROLINA?

YES, APPLICANTS ARE TYPICALLY REQUIRED TO HAVE A CURRENT CPR CERTIFICATION AS PART OF THE LICENSING PROCESS IN NORTH CAROLINA.

WHAT IS THE PROCESS TO APPLY FOR A MASSAGE THERAPY LICENSE IN NORTH CAROLINA?

APPLICANTS MUST SUBMIT A COMPLETED APPLICATION FORM, PROVIDE PROOF OF EDUCATION AND EXAM PASSAGE, SUBMIT FINGERPRINT BACKGROUND CHECKS, AND PAY THE REQUIRED FEES TO THE NORTH CAROLINA BOARD OF MESSAGE & BODYWORK THERAPY.

ARE THERE CONTINUING EDUCATION REQUIREMENTS TO MAINTAIN A MASSAGE THERAPY LICENSE IN NORTH CAROLINA?

YES, LICENSED MASSAGE THERAPISTS IN NORTH CAROLINA MUST COMPLETE CONTINUING EDUCATION REQUIREMENTS EVERY RENEWAL PERIOD, TYPICALLY INCLUDING AT LEAST 12 HOURS OF APPROVED COURSES.

HOW OFTEN DO I NEED TO RENEW MY MASSAGE THERAPY LICENSE IN NORTH CAROLINA?

CAN OUT-OF-STATE LICENSED MASSAGE THERAPISTS APPLY FOR LICENSURE IN NORTH CAROLINA?

YES, OUT-OF-STATE LICENSED MASSAGE THERAPISTS CAN APPLY FOR LICENSURE BY ENDORSEMENT IN NORTH CAROLINA IF THEIR CREDENTIALS AND EDUCATION MEET THE STATE'S REQUIREMENTS.

IS A BACKGROUND CHECK REQUIRED FOR MASSAGE THERAPY LICENSURE IN NORTH CAROLINA?

YES, ALL APPLICANTS MUST SUBMIT TO A CRIMINAL BACKGROUND CHECK, INCLUDING FINGERPRINTING, AS PART OF THE NORTH CAROLINA MASSAGE THERAPY LICENSE APPLICATION PROCESS.
