RECORD KEEPING AND JOURNAL REQUIREMENTS

MAINTAINING ACCURATE RECORDS IS A CRITICAL RESPONSIBILITY FOR NOTARIES. KEY POINTS INCLUDE:

- NOTARY JOURNAL: NEW YORK LAW REQUIRES NOTARIES TO KEEP A JOURNAL OF THEIR NOTARIAL ACTS, WHICH SHOULD INCLUDE:

WHAT IS THE PRIMARY ROLE OF A NOTARY PUBLIC IN NEW YORK?

THE PRIMARY ROLE OF A NOTARY PUBLIC IN NEW YORK IS TO SERVE AS AN IMPARTIAL WITNESS TO THE SIGNING OF DOCUMENTS, ENSURING THAT THE SIGNERS ARE WHO THEY CLAIM TO BE AND THAT THEY ARE SIGNING VOLUNTARILY.

WHAT ARE THE ELIGIBILITY REQUIREMENTS TO BECOME A NOTARY PUBLIC IN NEW YORK?

TO BECOME A NOTARY PUBLIC IN NEW YORK, YOU MUST BE AT LEAST 18 YEARS OLD, A RESIDENT OF NEW YORK STATE OR HAVE A BUSINESS IN THE STATE, AND YOU MUST NOT HAVE ANY FELONY CONVICTIONS.

TO RENEW A NOTARY PUBLIC COMMISSION IN NEW YORK, YOU MUST APPLY FOR RENEWAL THROUGH THE NEW YORK STATE DEPARTMENT OF STATE, SUBMIT A RENEWAL APPLICATION, AND PAY THE REQUIRED FEE BEFORE YOUR CURRENT COMMISSION EXPIRES.

WHAT TYPES OF DOCUMENTS CAN A NEW YORK NOTARY PUBLIC NOTARIZE?

A NEW YORK NOTARY PUBLIC CAN NOTARIZE A VARIETY OF DOCUMENTS, INCLUDING CONTRACTS, WILLS, DEEDS, POWERS OF ATTORNEY, AND ACKNOWLEDGMENTS OF SIGNATURES.

IS THERE A TEST REQUIRED TO BECOME A NOTARY PUBLIC IN NEW YORK?

YES, CANDIDATES FOR A NOTARY PUBLIC COMMISSION IN NEW YORK MUST PASS A WRITTEN EXAMINATION THAT COVERS THE DUTIES AND RESPONSIBILITIES OF A NOTARY.

HOW LONG IS A NOTARY PUBLIC COMMISSION VALID IN NEW YORK?

A NOTARY PUBLIC COMMISSION IN NEW YORK IS VALID FOR FOUR YEARS FROM THE DATE OF APPOINTMENT.

WHAT IS THE FEE FOR NOTARIZING A DOCUMENT IN NEW YORK?

IN NEW YORK, A NOTARY PUBLIC MAY CHARGE A MAXIMUM FEE OF \$2 PER SIGNATURE NOTARIZED, THOUGH MANY NOTARIES MAY CHOOSE NOT TO CHARGE A FEE.

CAN A NOTARY PUBLIC IN NEW YORK PERFORM REMOTE NOTARIZATIONS?

YES, NEW YORK ALLOWS REMOTE NOTARIZATION UNDER CERTAIN CONDITIONS, PARTICULARLY DURING EMERGENCIES, BUT NOTARIES MUST COMPLY WITH SPECIFIC REGULATIONS AND TECHNOLOGY REQUIREMENTS.

WHAT ARE THE CONSEQUENCES OF NOT FOLLOWING NOTARY REGULATIONS IN NEW YORK?
