EXAM FORMAT

- NUMBER OF QUESTIONS: THE EXAM TYPICALLY CONTAINS 75 QUESTIONS.
- PASSING SCORE: A SCORE OF 70% OR HIGHER IS REQUIRED TO PASS.
- DURATION: YOU WILL HAVE 1.5 HOURS TO COMPLETE THE EXAM.

ELIGIBILITY REQUIREMENTS

BEFORE YOU CAN SIT FOR THE NYS REAL ESTATE EXAM, YOU MUST MEET CERTAIN ELIGIBILITY REQUIREMENTS:

1. AGE: YOU MUST BE AT LEAST 18 YEARS OLD.
2. EDUCATION: YOU NEED TO COMPLETE A STATE-APPROVED 75-HOUR REAL ESTATE SALESPERSON COURSE OR A 120-HOUR BROKER COURSE.
3. BACKGROUND CHECK: A CRIMINAL BACKGROUND CHECK MAY BE REQUIRED, AND CERTAIN CONVICTIONS COULD DISQUALIFY YOU.

3. MANAGE YOUR TIME

KEEP AN EYE ON THE CLOCK AND ENSURE YOU ALLOCATE YOUR TIME WISELY. IF YOU FIND A QUESTION IS TOO CHALLENGING, MOVE ON AND COME BACK TO IT LATER.

4. STAY CALM AND FOCUSED

EXAM ANXIETY CAN HINDER YOUR PERFORMANCE. PRACTICE RELAXATION TECHNIQUES, SUCH AS DEEP BREATHING, TO MAINTAIN FOCUS DURING THE EXAM.
