SUPPORTING STARTERS

SUPPORTING SENTENCE STARTERS ARE USED TO PROVIDE REASONS, EVIDENCE, OR EXAMPLES THAT BACK UP THE WRITER'S OPINION. THEY HELP BUILD A CONVINCING ARGUMENT BY ADDING DEPTH AND DETAIL.

HOW TO USE OPINION WRITING SENTENCE STARTERS EFFECTIVELY

EFFECTIVELY USING OPINION WRITING SENTENCE STARTERS INVOLVES SELECTING THE RIGHT PHRASES FOR THE CONTEXT, MAINTAINING COHERENCE, AND ENSURING THAT THE OPINION FLOWS LOGICALLY THROUGHOUT THE PIECE. TIPS FOR TEACHING OPINION WRITING SENTENCE STARTERS
