AGE APPROPRIATENESS

DETERMINING WHETHER "ORGASM INC" IS APPROPRIATE FOR CHILDREN AND TEENAGERS INVOLVES SEVERAL FACTORS:

CONTENT RATING

RECOMMENDED AGE

- **PRE-TEENS (10-12):** MAY REQUIRE GUIDANCE AND CONTEXT IF THEY EXPRESS INTEREST IN VIEWING, AS THEY MIGHT NOT YET GRASP SOME OF THE MORE NUANCED THEMES.

DISCUSSION POINTS FOR PARENTS

ENGAGING WITH CHILDREN ABOUT THE THEMES PRESENTED IN "ORGASM INC" CAN FOSTER HEALTHY DISCUSSIONS ABOUT SEXUALITY. HERE ARE SOME POINTS TO CONSIDER:

4. **PROMOTE BODY POSITIVITY:** DISCUSS BODY IMAGE AND THE IMPORTANCE OF LOVING AND ACCEPTING ONESELF, REGARDLESS OF SOCIETAL STANDARDS.
5. **EMPHASIZE EDUCATION:** ENCOURAGE YOUR CHILDREN TO SEEK OUT REPUTABLE RESOURCES FOR LEARNING ABOUT SEXUAL HEALTH, ENSURING THEY UNDERSTAND THE DIFFERENCE BETWEEN RELIABLE INFORMATION AND SENSATIONALIZED MEDIA.

PARENTAL CONTROLS AND VIEWING OPTIONS

BEFORE ALLOWING YOUR CHILDREN TO WATCH "ORGASM INC," CONSIDER THE FOLLOWING OPTIONS TO MANAGE THEIR VIEWING EXPERIENCE:

PARENTAL CONTROLS

MANY STREAMING PLATFORMS OFFER PARENTAL CONTROL FEATURES THAT CAN LIMIT ACCESS TO CONTENT BASED ON AGE RATINGS. PARENTS CAN:

- **SET AGE RESTRICTIONS:** ADJUST SETTINGS TO RESTRICT ACCESS TO CONTENT THAT IS RATED FOR MATURE AUDIENCES.

Co-VIEWING AND GUIDANCE
