COMMON OVERHEAD CRANE TEST QUESTIONS

 - RAISE LOAD: ARM RAISED OVERHEAD WITH FINGERS EXTENDED
 - LOWER LOAD: ARM LOWERED WITH FINGERS POINTING DOWN
 - STOP: ARM EXTENDED HORIZONTALLY WITH PALM FACING THE OPERATOR
- QUESTION: WHAT SHOULD YOU DO IF THE CRANE BECOMES UNRESPONSIVE DURING OPERATION?
- ANSWER: IMMEDIATELY STOP ALL OPERATIONS, ENSURE THE AREA IS CLEAR OF PERSONNEL, AND TROUBLESHOOT THE ISSUE OR NOTIFY A QUALIFIED TECHNICIAN.

4. EMERGENCY PROCEDURES

- QUESTION: WHAT STEPS SHOULD YOU TAKE IN THE EVENT OF A POWER FAILURE WHILE OPERATING THE CRANE?
- ANSWER:
 1. REMAIN CALM AND STOP ALL OPERATIONS.
 2. SECURE THE LOAD, IF SAFE TO DO SO.
 3. FOLLOW COMPANY PROTOCOLS FOR POWER OUTAGES, WHICH MAY INCLUDE NOTIFYING A SUPERVISOR.
- QUESTION: HOW SHOULD YOU RESPOND TO A LOAD THAT IS SWINGING UNCONTROLLABLY?
- ANSWER: STOP ALL MOVEMENTS IMMEDIATELY AND AVOID TRYING TO CONTROL THE SWING MANUALLY. ALLOW THE LOAD TO COME TO A STOP BEFORE ATTEMPTING TO SECURE IT.

BEST PRACTICES FOR OVERHEAD CRANE OPERATIONS

ENSURING SAFE AND EFFICIENT OVERHEAD CRANE OPERATIONS INVOLVES ADHERING TO BEST PRACTICES. HERE ARE SOME KEY GUIDELINES:
