FOUNDATIONS OF PAPOULIS PROBABILITY THEORY

CONTINUOUS RANDOM VARIABLES ASSUME VALUES OVER AN INTERVAL OR THE ENTIRE REAL LINE, DESCRIBED BY PROBABILITY DENSITY FUNCTIONS (PDFs). THE PDF INTEGRATES TO ONE OVER ITS DOMAIN, AND PROBABILITIES FOR INTERVALS ARE COMPUTED USING INTEGRALS OF THE PDF.

KEY PROPERTIES OF RANDOM VARIABLES

RANDOM VARIABLES POSSESS IMPORTANT PROPERTIES SUCH AS EXPECTATION (MEAN), VARIANCE, AND HIGHER-ORDER MOMENTS. EXPECTATION PROVIDES THE AVERAGE OR EXPECTED VALUE, VARIANCE MEASURES DISPERSION, AND MOMENTS CAPTURE SHAPE CHARACTERISTICS OF THE DISTRIBUTION. THESE PROPERTIES ARE INSTRUMENTAL IN ANALYZING AND MODELING RANDOM PHENOMENA.

COMMON PROBABILITY DISTRIBUTIONS IN PAPOULIS FRAMEWORK

- **UNIFORM DISTRIBUTION:** ASSIGNS EQUAL PROBABILITY ACROSS AN INTERVAL FOR CONTINUOUS VARIABLES.
- **NORMAL (GAUSSIAN) DISTRIBUTION:** A FUNDAMENTAL CONTINUOUS DISTRIBUTION CHARACTERIZED BY MEAN AND VARIANCE, CRUCIAL IN MANY THEORETICAL AND APPLIED CONTEXTS.
- **EXPONENTIAL DISTRIBUTION:** MODELS THE TIME BETWEEN EVENTS IN A POISSON PROCESS.

EACH DISTRIBUTION HAS UNIQUE PROPERTIES AND APPLICATIONS, WITH PAPOULIS'S TREATMENT PROVIDING DETAILED DERIVATIONS AND PROOFS.

MARKOV PROPERTY

MANY STOCHASTIC PROCESSES SATISFY THE MARKOV PROPERTY, MEANING THE FUTURE STATE DEPENDS ONLY ON THE CURRENT STATE, NOT ON THE FULL HISTORY. THIS PROPERTY GREATLY SIMPLIFIES MODELING AND COMPUTATION.

CLASSIFICATION BASED ON STATE AND TIME DOMAINS

STOCHASTIC PROCESSES ARE CLASSIFIED AS DISCRETE-TIME OR CONTINUOUS-TIME, AND DISCRETE-STATE OR CONTINUOUS-STATE, FORMING CATEGORIES SUCH AS MARKOV CHAINS, GAUSSIAN PROCESSES, AND RENEWAL PROCESSES.
