UNDERSTANDING POLITICAL PARTIES

POLITICAL PARTIES ARE ORGANIZED GROUPS THAT SEEK TO GAIN AND MAINTAIN POLITICAL POWER WITHIN GOVERNMENT BY NOMINATING CANDIDATES, COORDINATING CAMPAIGNS, AND PROMOTING POLICY AGENDAS.
