- **TRANSFORMATIVE JUSTICE:** AN APPROACH FOCUSED ON ADDRESSING THE ROOT CAUSES OF CONFLICT AND FOSTERING HEALING AND RECONCILIATION INSTEAD OF RELYING SOLELY ON PUNITIVE MEASURES.

THE ROLE OF CONFLICT RESOLUTION

CONFLICT RESOLUTION IS A CRITICAL COMPONENT OF PEACE STUDIES, FOCUSING ON THE METHODS AND PROCESSES USED TO RESOLVE DISPUTES AND CONFLICTS. THE GOAL OF CONFLICT RESOLUTION IS TO ADDRESS THE UNDERLYING ISSUES THAT LEAD TO CONFLICT AND TO FIND SUSTAINABLE SOLUTIONS THAT PREVENT FUTURE DISPUTES.

METHODS OF CONFLICT RESOLUTION

4. **RESTORATIVE JUSTICE:** THIS FOCUSES ON REPAIRING HARM CAUSED BY CONFLICT THROUGH RECONCILIATION PROCESSES, INVOLVING BOTH VICTIMS AND OFFENDERS IN SEEKING HEALING AND RESTORATION.

THE IMPORTANCE OF PEACE STUDIES AND CONFLICT RESOLUTION

THE SIGNIFICANCE OF PEACE STUDIES AND CONFLICT RESOLUTION IS MULTIFACETED. UNDERSTANDING THESE DISCIPLINES CAN LEAD TO:

1. ENHANCED GLOBAL SECURITY

PEACE STUDIES EMPHASIZE THE IMPORTANCE OF SOCIAL JUSTICE. BY UNDERSTANDING THE ROOT CAUSES OF CONFLICT, PRACTITIONERS CAN ADVOCATE FOR EQUITABLE POLICIES THAT ADDRESS SYSTEMIC INEQUALITIES. THIS APPROACH ENSURES THAT ALL VOICES ARE HEARD, FOSTERING INCLUSIVE SOCIETIES WHERE EVERYONE CAN THRIVE.

3. EMPOWERMENT OF COMMUNITIES

3. RESOURCE LIMITATIONS
