CERTIFYING BODIES

SEVERAL ORGANIZATIONS ADMINISTER PEDIATRIC NURSE CERTIFICATION EXAMS, WITH THE PEDIATRIC NURSING CERTIFICATION BOARD (PNCB) BEING ONE OF THE MOST PROMINENT. THE AMERICAN NURSES CREDENTIALING CENTER (ANCC) ALSO OFFERS PEDIATRIC NURSING CERTIFICATION. THESE BODIES ESTABLISH ELIGIBILITY CRITERIA, DEVELOP EXAM CONTENT, AND ISSUE CERTIFICATION CREDENTIALS UPON SUCCESSFUL COMPLETION OF THE EXAM. UNDERSTANDING THE CERTIFYING ORGANIZATION'S REQUIREMENTS IS ESSENTIAL FOR CANDIDATES PREPARING TO TAKE THE EXAM.

ELIGIBILITY REQUIREMENTS

BEFORE REGISTERING FOR THE PEDIATRIC NURSE CERTIFICATION EXAM, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA SET BY THE CERTIFYING BODIES. EDUCATIONAL QUALIFICATIONS

ADDITIONALLY, MOST CERTIFYING ORGANIZATIONS REQUIRE A MINIMUM OF A NURSING DIPLOMA, ASSOCIATE DEGREE IN NURSING (ADN), OR BACHELOR OF SCIENCE IN NURSING (BSN) FROM AN ACCREDITED INSTITUTION.

CLINICAL EXPERIENCE

EXPERIENCE REQUIREMENTS USUALLY INCLUDE A MINIMUM NUMBER OF HOURS WORKED IN PEDIATRIC NURSING WITHIN A SPECIFIED TIMEFRAME, SUCH AS 1,800 CLINICAL HOURS OVER THE PAST 24 MONTHS. THIS CLINICAL EXPERIENCE MUST BE RELEVANT TO PEDIATRIC PATIENT CARE, INCLUDING NEWBORNS, INFANTS, CHILDREN, AND ADOLESCENTS, AND INVOLVE DIRECT PATIENT CARE RESPONSIBILITIES.

ADDITIONAL REQUIREMENTS

SOME CERTIFICATION PROGRAMS MAY REQUIRE CONTINUING EDUCATION CREDITS IN PEDIATRIC NURSING OR RELATED SUBJECTS PRIOR TO EXAM APPLICATION. CANDIDATES SHOULD VERIFY ALL PREREQUISITES WITH THE CERTIFYING ORGANIZATION TO ENSURE ELIGIBILITY.

EXAM CONTENT AND FORMAT

EXAM FORMAT

THE EXAM IS USUALLY COMPUTER-BASED AND CONSISTS OF MULTIPLE-CHOICE QUESTIONS DESIGNED TO EVALUATE CLINICAL JUDGMENT, DECISION-MAKING, AND KNOWLEDGE APPLICATION. THE NUMBER OF QUESTIONS VARIES BUT GENERALLY RANGES BETWEEN 150 AND 175 ITEMS, WITH A TIME LIMIT OF APPROXIMATELY THREE HOURS. THE EXAM IS SCORED ON A SCALED SYSTEM, AND A PASSING SCORE IS REQUIRED TO EARN CERTIFICATION.

RECERTIFICATION REQUIREMENTS

RECERTIFICATION MAY INVOLVE COMPLETING A SPECIFIED NUMBER OF CONTINUING EDUCATION UNITS (CEUs) RELATED TO PEDIATRIC NURSING, SUBMITTING DOCUMENTATION OF CLINICAL PRACTICE HOURS, OR RETAKING THE CERTIFICATION EXAM.

CONTINUING EDUCATION OPPORTUNITIES

NURSES CAN FULFILL RECERTIFICATION REQUIREMENTS THROUGH VARIOUS ACTIVITIES SUCH AS ATTENDING WORKSHOPS, COMPLETING ONLINE COURSES, PARTICIPATING IN CONFERENCES, OR ENGAGING IN PEDIATRIC NURSING RESEARCH AND QUALITY IMPROVEMENT PROJECTS.

IMPORTANCE OF LIFELONG LEARNING
