MANY STATE NURSING BOARDS AND CERTIFICATION BODIES MANDATE A MINIMUM NUMBER OF CONTINUING EDUCATION HOURS TO RENEW LICENSES AND CERTIFICATIONS, HIGHLIGHTING ITS REGULATORY IMPORTANCE.

ENSURING QUALITY PATIENT CARE

STATE BOARD OF NURSING REQUIREMENTS

EACH STATE NURSING BOARD SETS ITS OWN CONTINUING EDUCATION MANDATES FOR NURSE PRACTITIONERS. COMMONLY, STATES REQUIRE A SET NUMBER OF CONTACT HOURS WITHIN A RENEWAL PERIOD, WITH SOME SPECIFYING PEDIATRIC-FOCUSED CONTENT FOR PNPs. COMPLIANCE IS NECESSARY TO MAINTAIN LICENSURE AND AVOID PENALTIES.

CERTIFICATION MAINTENANCE

NATIONAL CERTIFICATION ORGANIZATIONS REQUIRE PEDIATRIC NURSE PRACTITIONERS TO COMPLETE CONTINUING EDUCATION AS PART OF THE RECERTIFICATION PROCESS. FOR EXAMPLE, THE PNCB REQUIRES A CERTAIN NUMBER OF CONTINUING EDUCATION HOURS EVERY FIVE YEARS, INCLUDING CLINICAL PRACTICE HOURS AND PROFESSIONAL DEVELOPMENT ACTIVITIES TO DEMONSTRATE ONGOING COMPETENCY.

CHOOSING THE RIGHT CONTINUING EDUCATION COURSES
