EXAM STRUCTURE

THE PRAXIS SPEECH-LANGUAGE PATHOLOGY (5331) EXAM CONSISTS OF:

- 132 MULTIPLE-CHOICE QUESTIONS
- A TIME LIMIT OF 150 MINUTES
- A SCORING RANGE FROM 100 TO 200, WITH A PASSING SCORE GENERALLY SET AROUND 162, THOUGH THIS CAN VARY BY STATE.

THE QUESTIONS ARE DIVIDED INTO VARIOUS CATEGORIES THAT REFLECT THE COMPETENCIES REQUIRED FOR EFFECTIVE PRACTICE.

 - EVIDENCE-BASED PRACTICES
 - TREATMENT PLANNING AND GOAL SETTING

UNDERSTANDING THESE CONTENT CATEGORIES IS CRUCIAL FOR CANDIDATES AS THEY STUDY FOR THE EXAM.

IMPORTANCE OF PRAXIS PRACTICE QUESTIONS
