ELIGIBILITY REQUIREMENTS FOR THE MICHIGAN BUILDERS LICENSE

BEFORE APPLYING FOR THE PSI EXAM MICHIGAN BUILDERS LICENSE, CANDIDATES MUST MEET SPECIFIC ELIGIBILITY CRITERIA ESTABLISHED BY THE MICHIGAN DEPARTMENT OF LICENSING AND REGULATORY AFFAIRS (LARA). EXPERIENCE REQUIREMENTS

EVALUATED AS PART OF THE ELIGIBILITY PROCESS.
