MHIC SETS THE ELIGIBILITY CRITERIA, EXAM CONTENT GUIDELINES, AND ENFORCEMENT POLICIES TO ENSURE THAT LICENSEES MAINTAIN HIGH STANDARDS OF WORKMANSHIP AND ETHICAL CONDUCT THROUGHOUT THEIR CAREERS.

REGISTRATION AND ELIGIBILITY REQUIREMENTS

APPLICATION PROCESS

CANDIDATES MUST SUBMIT THE REQUIRED DOCUMENTATION AND FEES TO THE MHIC BEFORE RECEIVING AUTHORIZATION TO REGISTER FOR THE PSI MARYLAND HOME IMPROVEMENT EXAM. THIS INCLUDES BACKGROUND CHECKS AND VERIFICATION OF BUSINESS CREDENTIALS OR EXPERIENCE IN THE HOME IMPROVEMENT INDUSTRY. POST-EXAM LICENSING PROCESS

AFTER SUCCESSFULLY PASSING THE PSI MARYLAND HOME IMPROVEMENT EXAM, CANDIDATES MUST COMPLETE ADDITIONAL STEPS TO OBTAIN THEIR CONTRACTOR LICENSE AND LEGALLY OPERATE WITHIN MARYLAND.

LICENSE APPLICATION AND FEES
