EDUCATION AND TRAINING REQUIREMENTS

BASIC NURSING EDUCATION

A REGISTERED NURSE (RN) LICENSE IS REQUIRED AS A MINIMUM CREDENTIAL. THIS IS ACHIEVED THROUGH COMPLETION OF AN ACCREDITED NURSING PROGRAM SUCH AS AN ASSOCIATE DEGREE IN NURSING (ADN) OR BACHELOR OF SCIENCE IN NURSING (BSN), COUPLED WITH PASSING THE NCLEX-RN EXAMINATION.

SPECIALIZED PSYCHIATRIC NURSING TRAINING

POST-BASIC EDUCATION OFTEN INCLUDES OBTAINING A CERTIFICATION IN PSYCHIATRIC AND MENTAL HEALTH NURSING. ADVANCED DEGREES SUCH AS A MASTER OF SCIENCE IN NURSING (MSN) WITH A PSYCHIATRIC MENTAL HEALTH NURSE PRACTITIONER (PMHNP) FOCUS PROVIDE DEEPER CLINICAL EXPERTISE AND AUTONOMOUS PRACTICE CAPABILITIES.

CONTINUING EDUCATION AND CERTIFICATION
