NEUTRONS ARE UNCHARGED PARTICLES WITH HIGH PENETRATION, NECESSITATING SPECIALIZED SHIELDING SUCH AS WATER OR POLYETHYLENE. RECOGNIZING THESE TYPES HELPS IN UNDERSTANDING EXPOSURE RISKS AND APPROPRIATE SAFETY MEASURES.

SOURCES OF RADIATION

RADIATION SOURCES CAN BE NATURAL OR ARTIFICIAL. NATURAL SOURCES INCLUDE COSMIC RAYS, RADON GAS, AND NATURALLY OCCURRING RADIOACTIVE MATERIALS IN THE EARTH. ALARA PRINCIPLE

ALARA STANDS FOR "AS LOW AS REASONABLY ACHIEVABLE" AND EMPHASIZES MINIMIZING RADIATION EXPOSURE TO THE LOWEST FEASIBLE LEVELS. THIS PRINCIPLE ENCOURAGES EMPLOYING ALL PRACTICAL METHODS TO REDUCE EXPOSURE WITHOUT COMPROMISING OPERATIONAL EFFICIENCY OR SAFETY. COMPLIANCE WITH ALARA IS A CORNERSTONE OF RADIATION SAFETY PROGRAMS AND OFTEN FEATURES PROMINENTLY IN RADIATION SAFETY TEST ANSWERS.

REGULATORY STANDARDS AND COMPLIANCE

REGULATORY STANDARDS AND COMPLIANCE ENSURE THAT RADIATION USE ADHERES TO ESTABLISHED SAFETY LIMITS AND LEGAL REQUIREMENTS. EXPOSURE LIMITS AND DOSE CONSTRAINTS

REGULATORY LIMITS SPECIFY MAXIMUM ALLOWABLE OCCUPATIONAL AND PUBLIC RADIATION DOSES. FOR EXAMPLE, OCCUPATIONAL EXPOSURE LIMITS ARE GENERALLY SET AT 5 REM (50 MILLISIEVERTS) PER YEAR, WHILE PUBLIC EXPOSURE LIMITS ARE MUCH LOWER.
