EXAM STRUCTURE AND FORMAT

THE ALABAMA REAL ESTATE EXAM CONSISTS OF TWO PARTS: THE NATIONAL SECTION AND THE STATE-SPECIFIC SECTION.

1. NATIONAL SECTION: THIS PORTION TYPICALLY COVERS GENERAL REAL ESTATE PRINCIPLES AND PRACTICES, INCLUDING:

- PROPERTY OWNERSHIP
- LAND USE CONTROLS AND REGULATIONS
- VALUATION AND MARKET ANALYSIS
- FINANCING AND CLOSING PROCEDURES

2. STATE-SPECIFIC SECTION: THIS PART FOCUSES ON LAWS AND REGULATIONS THAT ARE UNIQUE TO ALABAMA, INCLUDING:

- ALABAMA REAL ESTATE LICENSE LAW
- AGENCY RELATIONSHIPS
- PROPERTY DISCLOSURES
- CONTRACTS AND OFFERS

THE EXAM IS COMPUTER-BASED AND CONSISTS OF A TOTAL OF 140 QUESTIONS, DIVIDED AS FOLLOWS:

- 80 QUESTIONS ON NATIONAL TOPICS
- 60 QUESTIONS ON STATE-SPECIFIC TOPICS

TO PASS, CANDIDATES MUST ACHIEVE A MINIMUM SCORE OF 70%.

PREREQUISITES FOR TAKING THE EXAM

BEFORE YOU CAN TAKE THE REAL ESTATE EXAM IN ALABAMA, YOU MUST MEET CERTAIN PREREQUISITES:

1. AGE REQUIREMENT: YOU MUST BE AT LEAST 19 YEARS OLD.
2. EDUCATION: COMPLETION OF A 60-HOUR PRE-LICENSING COURSE FROM AN ACCREDITED REAL ESTATE SCHOOL IS MANDATORY. THIS COURSE COVERS ESSENTIAL TOPICS AND PREPARES YOU FOR THE EXAM.
3. BACKGROUND CHECK: A BACKGROUND CHECK IS REQUIRED, AND ANY FELONY CONVICTIONS MAY AFFECT YOUR ELIGIBILITY.

4. APPLICATION: YOU NEED TO SUBMIT AN APPLICATION TO THE ALABAMA REAL ESTATE COMMISSION, ALONG WITH THE REQUIRED FEES.

PREPARING FOR THE REAL ESTATE EXAM

1. REGISTER: CREATE AN ACCOUNT ON THE EXAM PROVIDER'S WEBSITE (PEARSON VUE).
2. SELECT A DATE AND LOCATION: CHOOSE A CONVENIENT DATE AND TESTING CENTER.

3. **PAY FEES:** PAY THE EXAMINATION FEE, WHICH IS TYPICALLY AROUND \$77.

MAKE SURE TO SCHEDULE YOUR EXAM WELL IN ADVANCE, AS SLOTS CAN FILL UP QUICKLY.

WHAT TO EXPECT ON EXAM DAY

ON THE DAY OF THE EXAM, IT'S ESSENTIAL TO BE PREPARED AND ORGANIZED. HERE'S A CHECKLIST TO FOLLOW:

1. BRING REQUIRED IDENTIFICATION

YOU MUST PRESENT A VALID FORM OF IDENTIFICATION, SUCH AS:

- A GOVERNMENT-ISSUED PHOTO ID
- YOUR SOCIAL SECURITY NUMBER

2. ARRIVE EARLY

ARRIVE AT LEAST 30 MINUTES EARLY TO ALLOW TIME FOR CHECK-IN. THIS HELPS REDUCE ANXIETY AND ENSURES YOU HAVE TIME TO SETTLE IN.

3. FOLLOW EXAM PROTOCOLS

FAMILIARIZE YOURSELF WITH THE EXAM RULES, INCLUDING:

- NO ELECTRONIC DEVICES ALLOWED
- ADHERING TO TIME LIMITS
- MAINTAINING A QUIET ENVIRONMENT

AFTER THE EXAM: NEXT STEPS

ONCE YOU COMPLETE THE EXAM, YOU'LL RECEIVE YOUR RESULTS IMMEDIATELY. IF YOU PASS, YOU CAN PROCEED WITH THE LICENSING PROCESS. HERE ARE THE STEPS TO FOLLOW:

1. **SUBMIT YOUR APPLICATION:** COMPLETE THE LICENSING APPLICATION AND SUBMIT IT TO THE ALABAMA REAL ESTATE COMMISSION.
2. **PAY THE LICENSING FEE:** THERE WILL BE A FEE ASSOCIATED WITH OBTAINING YOUR LICENSE, TYPICALLY AROUND \$150.
3. **COMPLETE POST-LICENSING EDUCATION:** ALABAMA REQUIRES NEW LICENSEES TO COMPLETE A 30-HOUR POST-LICENSING COURSE WITHIN THE FIRST SIX MONTHS OF LICENSURE.

CANDIDATES MUST BRING A VALID GOVERNMENT-ISSUED PHOTO ID, SUCH AS A DRIVER'S LICENSE OR PASSPORT, WHEN TAKING THE ALABAMA REAL ESTATE EXAM.

HOW OFTEN CAN I RETAKE THE ALABAMA REAL ESTATE EXAM IF I FAIL?

IF YOU FAIL THE ALABAMA REAL ESTATE EXAM, YOU CAN RETAKE IT AS MANY TIMES AS NECESSARY, BUT YOU MUST PAY THE EXAM FEE EACH TIME YOU RETAKE IT.

ARE THERE ANY AGE REQUIREMENTS TO TAKE THE ALABAMA REAL ESTATE EXAM?

YES, CANDIDATES MUST BE AT LEAST 19 YEARS OLD TO TAKE THE ALABAMA REAL ESTATE EXAM.

WHAT SHOULD I DO IF I HAVE SPECIAL ACCOMMODATIONS FOR THE ALABAMA REAL ESTATE EXAM?

IF YOU REQUIRE SPECIAL ACCOMMODATIONS FOR THE ALABAMA REAL ESTATE EXAM, YOU SHOULD CONTACT PEARSON VUE IN ADVANCE TO REQUEST THE NECESSARY ARRANGEMENTS AND PROVIDE DOCUMENTATION OF YOUR NEEDS.
