OVERALL, CANDIDATES HAVE A TOTAL OF 3.5 HOURS TO COMPLETE THE EXAM, AND A PASSING SCORE IS REQUIRED IN BOTH SECTIONS TO OBTAIN A REAL ESTATE LICENSE.

ARE THERE ANY PREREQUISITES FOR TAKING THE MASSACHUSETTS REAL ESTATE PRACTICE EXAM?

YES, YOU MUST COMPLETE A 40-HOUR PRE-LICENSING COURSE APPROVED BY THE MASSACHUSETTS REAL ESTATE BOARD BEFORE YOU CAN TAKE THE EXAM.
