UNDERSTANDING PARALLEL STRUCTURE IN WRITING

PARALLELISM COMMONLY APPEARS IN LISTS, COMPARISONS, AND PAIRED IDEAS, ENHANCING BOTH THE FLOW AND EMPHASIS OF SENTENCES. ELEMENTS THAT REQUIRE PARALLELISM

COMMON ELEMENTS IN SENTENCES THAT REQUIRE PARALLEL STRUCTURE INCLUDE:

COMMON ERRORS WHEN REVISING SENTENCES FOR PARALLELISM

MIXING GRAMMATICAL FORMS

REVISING SUCH SENTENCES TO CREATE PARALLEL STRUCTURE ANSWERS INVOLVES CONVERTING ALL ELEMENTS INTO THE SAME FORM, SUCH AS "READING, SWIMMING, AND BIKING."

INCONSISTENT VERB TENSES

ANOTHER COMMON MISTAKE IS INCONSISTENT VERB TENSES WITHIN A SENTENCE. FOR EXAMPLE: "HE COOKED DINNER, CLEANS THE HOUSE, AND WAS DOING LAUNDRY." TO REVISE THIS SENTENCE FOR PARALLELISM, VERBS SHOULD BE ALIGNED IN TENSE: "HE COOKED DINNER, CLEANED THE HOUSE, AND DID THE LAUNDRY."

UNEQUAL EMPHASIS IN COMPARISONS

COMPARISONS CAN LOSE EFFECTIVENESS IF ELEMENTS ARE NOT PARALLEL. AN EXAMPLE IS "SHE IS SMARTER THAN ANYONE IN THE ROOM IS." THE SENTENCE IS CORRECT BUT CAN BE CLEARER IF PARALLEL STRUCTURE IS EMPHASIZED: "SHE IS SMARTER THAN ANYONE ELSE IN THE ROOM."

TECHNIQUES FOR REVISING SENTENCES TO CREATE PARALLEL STRUCTURE

EFFECTIVE REVISION STRATEGIES CAN HELP WRITERS ENSURE THEIR SENTENCES MAINTAIN PARALLELISM. THESE TECHNIQUES ARE PRACTICAL TOOLS FOR PRODUCING POLISHED AND BALANCED WRITING.

IDENTIFY THE ELEMENTS TO ALIGN

BEGIN BY PINPOINTING THE PARTS OF THE SENTENCE THAT NEED TO BE PARALLEL, SUCH AS ITEMS IN A LIST, PAIRED PHRASES, OR CLAUSES. HIGHLIGHTING THESE ELEMENTS MAKES IT EASIER TO COMPARE THEIR GRAMMATICAL FORMS AND REVISE ACCORDINGLY.

USE CONSISTENT GRAMMATICAL FORMS

ENSURE THAT ALL ELEMENTS SHARE THE SAME GRAMMATICAL FORM, WHETHER THEY ARE NOUNS, VERBS, GERUNDS, INFINITIVES, OR CLAUSES. THIS CONSISTENCY IS THE CORE OF PARALLELISM AND IMPROVES SENTENCE CLARITY.

APPLY CORRELATIVE CONJUNCTIONS PROPERLY

WHEN USING CORRELATIVE CONJUNCTIONS LIKE "EITHER...OR," "NEITHER...NOR," OR "BOTH...AND," MAKE SURE THE ELEMENTS FOLLOWING EACH PART OF THE CONJUNCTION MATCH GRAMMATICALLY. FOR EXAMPLE, "SHE WILL EITHER STUDY MEDICINE OR BECOME AN ENGINEER" SHOULD BE REVISED TO "SHE WILL EITHER STUDY MEDICINE OR STUDY ENGINEERING" FOR PARALLELISM.

READ SENTENCES ALOUD

READING SENTENCES ALOUD HELPS DETECT AWKWARDNESS OR IMBALANCE CAUSED BY LACK OF PARALLEL STRUCTURE. SMOOTH, RHYTHMIC SENTENCES OFTEN INDICATE CORRECT PARALLELISM.

USE REVISION TOOLS AND CHECKLISTS

UTILIZING GRAMMAR CHECKERS AND PARALLELISM CHECKLISTS DURING THE REVISION PROCESS CAN PROVIDE ADDITIONAL SUPPORT IN IDENTIFYING AND CORRECTING ERRORS RELATED TO PARALLEL STRUCTURE.

REVISED: "SHE LIKES JOGGING, SWIMMING, AND BIKING."

EXAMPLE 3: CORRELATIVE CONJUNCTIONS

INCORRECT: "HE WANTS NEITHER TO SING NOR DANCING."

REVISED: "HE WANTS NEITHER TO SING NOR TO DANCE."

5. FIND AND FIX THE ERROR: "I ENJOY COOKING, CLEANING THE HOUSE, AND TO SHOP."

FREQUENTLY ASKED QUESTIONS

WHAT IS PARALLEL STRUCTURE IN SENTENCE REVISION?

SURE! NON-PARALLEL: "SHE LIKES HIKING, TO SWIM, AND BIKING." REVISED PARALLEL: "SHE LIKES HIKING, SWIMMING, AND BIKING."

WHAT ARE COMMON MISTAKES WHEN CREATING PARALLEL STRUCTURES?

HOW CAN I REVISE A SENTENCE WITH MIXED INFINITIVES AND GERUNDS TO BE PARALLEL?

CONVERT ALL VERBS TO THE SAME FORM. FOR EXAMPLE, CHANGE "TO JOG, SWIMMING, AND TO BIKE" TO EITHER "JOGGING, SWIMMING, AND BIKING" OR "TO JOG, TO SWIM, AND TO BIKE."
