UNDERSTANDING THE RHODE ISLAND BAR EXAM

CANDIDATES MUST DEMONSTRATE PROFICIENCY IN VARIOUS LEGAL SUBJECTS APPLICABLE UNDER RHODE ISLAND LAW AS WELL AS GENERAL LEGAL PRINCIPLES.

RELEASE TIMELINE FOR RHODE ISLAND BAR EXAM RESULTS

SCORES ON THE MBE TYPICALLY ACCOUNT FOR 50% OF THE TOTAL SCORE, WITH THE REMAINING 50% COMING FROM THE COMBINED ESSAY AND PERFORMANCE TEST SCORES. THIS BALANCED APPROACH ENSURES THAT CANDIDATES ARE ASSESSED ON BOTH THEORETICAL KNOWLEDGE AND PRACTICAL SKILLS.

RETAKE THE EXAM REQUIRES CAREFUL PREPARATION AND REVIEW OF PRIOR PERFORMANCE TO ADDRESS WEAKNESSES. THE BOARD ENCOURAGES CANDIDATES TO UTILIZE AVAILABLE RESOURCES SUCH AS PREPARATORY COURSES AND STUDY MATERIALS TO IMPROVE THEIR CHANCES OF SUCCESS.

STEPS TO RETAKE THE BAR EXAM
