OVERVIEW OF SAFEGUARD DEWORMER BLOCKS

SAFEGUARD DEWORMER BLOCKS ARE A MEDICATED FEED SUPPLEMENT DESIGNED TO PROVIDE CONTINUOUS PARASITE CONTROL FOR GRAZING LIVESTOCK. THESE BLOCKS TYPICALLY CONTAIN FENBENDAZOLE, A BROAD-SPECTRUM ANTHELMINTIC EFFECTIVE AGAINST VARIOUS INTERNAL PARASITES INCLUDING ROUNDWORMS, LUNGWORMS, AND TAPEWORMS. THE SLOW-RELEASE FORMULATION ENCOURAGES ANIMALS TO CONSUME THE BLOCK GRADUALLY OVER SEVERAL WEEKS, MAINTAINING AN EFFECTIVE DOSE WITHIN THE BLOODSTREAM. THIS METHOD REDUCES THE NEED FOR FREQUENT DOSING WHILE PROMOTING CONSISTENT PARASITE SUPPRESSION. SAFEGUARD DEWORMER BLOCKS ARE SUITABLE FOR CATTLE, SHEEP, AND GOATS AND ARE ESPECIALLY USEFUL IN PASTURE-BASED SYSTEMS WHERE ORAL DOSING IS IMPRACTICAL. UNDERSTANDING THE PRODUCT COMPOSITION AND MODE OF ACTION IS KEY TO APPLYING THE SAFEGUARD DEWORMER BLOCK INSTRUCTIONS CORRECTLY FOR MAXIMUM EFFICACY.

DOSAGE AND ADMINISTRATION GUIDELINES

CORRECT DOSAGE IS CRITICAL IN FOLLOWING SAFEGUARD DEWORMER BLOCK INSTRUCTIONS TO ENSURE EFFECTIVE PARASITE CONTROL AND PREVENT RESISTANCE. THE BLOCKS ARE FORMULATED TO DELIVER THE APPROPRIATE AMOUNT OF ACTIVE INGREDIENT BASED ON THE ANIMAL'S WEIGHT AND DAILY CONSUMPTION RATES. TYPICALLY, ONE BLOCK IS DESIGNED TO TREAT MULTIPLE ANIMALS OVER A SPECIFIED PERIOD, DEPENDING ON HERD SIZE AND GRAZING INTENSITY.

RECOMMENDED DOSAGE

THE MANUFACTURER'S GUIDELINES GENERALLY RECOMMEND ONE BLOCK PER 10 TO 15 HEAD OF CATTLE, OR ONE BLOCK PER 5 TO 10 SHEEP OR GOATS. ANIMALS CONSUME THE BLOCK AD LIBITUM, WITH DAILY INTAKE AVERAGING ABOUT 35 TO 50 GRAMS PER ANIMAL. THIS CONSUMPTION RATE PROVIDES THE TARGET DOSAGE OF FENBENDAZOLE, ENSURING EFFECTIVE PARASITE CONTROL WITHOUT OVERDOSING.

ADJUSTMENTS BASED ON ANIMAL WEIGHT AND CONDITION

WHILE THE BLOCK IS DESIGNED FOR FREE-CHOICE CONSUMPTION, ADJUSTMENTS MAY BE NECESSARY FOR ANIMALS WITH SIGNIFICANTLY DIFFERENT WEIGHTS OR NUTRITIONAL STATUSES. REGULAR MONITORING OF ANIMAL CONDITION AND PARASITE BURDEN IS ADVISED TO TAILOR DEWORMING STRATEGIES ACCORDINGLY.

APPLICATION INSTRUCTIONS FOR DIFFERENT LIVESTOCK

APPLYING SAFEGUARD DEWORMER BLOCKS CORRECTLY INVOLVES STRATEGIC PLACEMENT, MONITORING CONSUMPTION, AND ADAPTING TO THE SPECIFIC NEEDS OF DIFFERENT LIVESTOCK SPECIES. PROPER APPLICATION ENSURES THAT ALL ANIMALS HAVE ADEQUATE ACCESS AND RECEIVE THE INTENDED DOSAGE OVER THE TREATMENT PERIOD.

USING SAFEGUARD BLOCKS FOR CATTLE

FOR CATTLE, PLACE THE BLOCKS IN SHADED, DRY AREAS WITHIN THE PASTURE WHERE ANIMALS CONGREGATE, SUCH AS NEAR WATER SOURCES OR FEEDING AREAS. POSITION BLOCKS ON RAISED PLATFORMS OR PALLETS TO PREVENT CONTAMINATION FROM MUD OR FECES. REGULARLY INSPECT THE BLOCKS TO ENSURE THEY REMAIN INTACT AND ACCESSIBLE, REPLACING THEM AS NEEDED.

USING SAFEGUARD BLOCKS FOR SHEEP AND GOATS

SHEEP AND GOATS REQUIRE SIMILAR PLACEMENT CONSIDERATIONS BUT MAY CONSUME BLOCKS MORE QUICKLY DUE TO THEIR SMALLER SIZE. PROVIDING ONE BLOCK PER 5 TO 10 ANIMALS IS TYPICAL. BLOCKS SHOULD BE POSITIONED IN SHELTERED LOCATIONS TO PREVENT WEATHER-RELATED DEGRADATION AND TO ENCOURAGE CONSISTENT CONSUMPTION. IT IS IMPORTANT TO OBSERVE ANIMALS TO CONFIRM THEY ARE CONSUMING THE BLOCKS AND TO PREVENT DOMINANT ANIMALS FROM MONOPOLIZING THE RESOURCE.

MONITORING CONSUMPTION AND ANIMAL BEHAVIOR

REGULAR OBSERVATION IS ESSENTIAL TO VERIFY THAT ALL ANIMALS ARE CONSUMING THE DEWORMER BLOCKS ADEQUATELY. UNEVEN CONSUMPTION CAN LEAD TO INEFFECTIVE PARASITE CONTROL AND INCREASED RISK OF RESISTANCE. ADJUST BLOCK PLACEMENT OR PROVIDE ADDITIONAL BLOCKS AS NECESSARY TO PROMOTE EQUAL ACCESS FOR ALL HERD MEMBERS.

SAFETY AND HANDLING PRECAUTIONS

FOLLOWING SAFETY GUIDELINES IS AN INTEGRAL PART OF SAFEGUARD DEWORMER BLOCK INSTRUCTIONS TO PROTECT BOTH HANDLERS AND ANIMALS. THE ACTIVE INGREDIENT, FENBENDAZOLE, IS GENERALLY SAFE, BUT PROPER HANDLING REDUCES EXPOSURE RISKS AND MAINTAINS PRODUCT INTEGRITY.

PERSONAL PROTECTIVE MEASURES

WHEN HANDLING DEWORMER BLOCKS, WEAR GLOVES TO AVOID SKIN CONTACT AND WASH HANDS THOROUGHLY AFTERWARD. AVOID INHALATION OF DUST OR PARTICLES THAT MAY BE RELEASED WHEN HANDLING OR CUTTING BLOCKS. KEEP BLOCKS OUT OF REACH OF CHILDREN AND PETS TO PREVENT ACCIDENTAL INGESTION.

ANIMAL SAFETY CONSIDERATIONS

ENSURE ANIMALS ARE HEALTHY BEFORE ADMINISTERING THE BLOCKS, AS SEVERELY ILL OR DEBILITATED LIVESTOCK MAY REQUIRE VETERINARY CONSULTATION. AVOID USING THE BLOCKS IN PREGNANT ANIMALS UNLESS APPROVED BY A VETERINARIAN. OBSERVE ANIMALS FOR ANY ADVERSE REACTIONS AFTER INTRODUCING THE DEWORMER BLOCK AND REPORT UNUSUAL BEHAVIOR OR SYMPTOMS PROMPTLY.

STORAGE AND SHELF LIFE

STORAGE TIPS

- KEEP BLOCKS IN ORIGINAL PACKAGING UNTIL USE TO PROTECT FROM CONTAMINATION
- STORE IN A WELL-VENTILATED AREA WITH STABLE TEMPERATURE
- AVOID STACKING HEAVY OBJECTS ON TOP OF THE BLOCKS TO PREVENT DAMAGE
- CHECK EXPIRATION DATES AND USE BLOCKS BEFORE EXPIRY

SHELF LIFE CONSIDERATIONS

MOST SAFEGUARD DEWORMER BLOCKS HAVE A SHELF LIFE OF 2 TO 3 YEARS WHEN STORED PROPERLY. USING EXPIRED OR IMPROPERLY STORED BLOCKS CAN COMPROMISE TREATMENT OUTCOMES AND CONTRIBUTE TO PARASITE RESISTANCE. REGULARLY INSPECT BLOCKS FOR SIGNS OF DETERIORATION, SUCH AS CRUMBLING OR DISCOLORATION, BEFORE ADMINISTERING TO ANIMALS.

INTEGRATING DEWORMER BLOCKS INTO PARASITE CONTROL PROGRAMS

PREVENTING ANTHELMINTIC RESISTANCE
