UNDERSTANDING THE PURPOSE OF A BUSINESS ETHICS POLICY

- **ANTI-BRIBERY AND CORRUPTION:** REJECT ANY FORM OF BRIBERY, KICKBACKS, OR UNETHICAL INDUCEMENTS IN BUSINESS TRANSACTIONS.
- **HEALTH AND SAFETY:** ADHERE TO WORKPLACE SAFETY PROTOCOLS TO PROTECT THE WELLBEING OF ALL EMPLOYEES.

IMPLEMENTING AND ENFORCING THE ETHICS POLICY
