TIME MANAGEMENT

ALLOCATING TIME WISELY ACROSS ALL QUESTIONS PREVENTS RUSHING AT THE END AND ALLOWS FOR REVIEW. PRACTICING WITH SAMPLE EA EXAM QUESTIONS UNDER TIMED CONDITIONS CAN HELP DEVELOP PACING SKILLS.
